The board of directors (the "Board of Directors") of the Merging UCITS, has decided to merge the Merging Sub-Fund into UBS (Lux) Strategy Fund – Yield Sustainable (EUR) (the "Receiving Sub-Fund"), a sub-fund of UBS (Lux) Strategy Fund, a fonds commun de placement incorporated under the laws of the Grand Duchy of Luxembourg, registered with the Luxembourg Trade and Companies Register under number K 299 ( (the "Receiving UCITS") in compliance with article 1(20)(a) of the law of 17 December 2010 on undertakings for collective investment as amended (the "Merger"). You were informed by way of publication on 19 June 2024. The Merger has become effective on 26 July 2024 (the "Effective Date").
