Dear Shareholders,

You were informed by notice dated 24 September 2024 that the board of directors (the "Board of Directors") of the Receiving UCITS, has decided to proceed to a merger by absorption of the Credit Suisse (Lux) Corporate Short Duration EUR Bond Fund (the "Merging Sub-Fund"), a sub-fund of CS Investment Funds 14, a *fonds commun de placement* established under the laws of the Grand Duchy of Luxembourg, registered with the Luxembourg Trade and Companies Register under number K673 (the "Merging UCITS") into the Receiving Sub-Fund in compliance with article 1(20)(a) of the law of 17 December 2010 on undertakings for collective investment as amended (the "Merger").

The Merger was schedule to become effective on 8 November 2024 (the "**Effective Date**"). It has meanwhile been consummated and resulted in the following liquidation proceeds:
