Dear Shareholders,

You have been informed by way of notice dated 4 November 2024 that the board of directors (the "**Board of Directors**") of the Receiving UCITS, has decided to proceed to a merger by absorption of the Credit Suisse (Lux) Emerging Market Corporate Bond Fund (the "**Merging Sub-Fund**"), a sub-fund of Credit Suisse Investment Funds 3, a *société d'investissement à capital variable*, formed and existing under the laws of the Grand Duchy of Luxemburg having its registered office at 5, rue Jean Monnet, L-2180, Grand Duchy of Luxembourg and registered with the RCS under number B 89370 (the "**Merging UCITS**") into the Receiving Sub-Fund in compliance with article 1(20)(a) of the law of 17 December 2010 on undertakings for collective investment as amended (the "**Merger**").

The Merger was scheduled to become effective on 13 December 2024 (the "Effective Date"). The Merger is meanwhile completed and resulted in the following conversion ratios:
