Dear Shareholders,

The board of directors (the **"Board of Directors"**) of the Receiving UCITS, has informed you with letter dated 22 May 2024 that it has decided to proceed to a merger by absorption of the Credit Suisse European Quality Dividend Equity Fund (the **"Merging Sub-Fund"**), a sub-fund of Credit Suisse Investment Funds 2, a *société d'investissement à capital variable*, formed and existing under the laws of the Grand Duchy of Luxemburg having its registered office at 5, rue Jean Monnet, L-2180, Grand Duchy of Luxembourg and registered with the RCS under number B 124019 (the **"Merging UCITS"**) into the Receiving Sub-Fund in compliance with article 1(20)(a) of the law of 17 December 2010 on undertakings for collective investment as amended (the **"Merger"**). The Merger shall become effective on 28 June 2024 (the **"Effective Date"**).
