The Management Company, on behalf of the boards of directors of UBS (Lux) SICAV 2 and UBS (Lux) Bond SICAV, both a "Société d'Investissement à Capital Variable (SICAV)", has informed you on 10 August 2023 of the decision to merge the sub-fund UBS (Lux) SICAV 2 – Low Duration EUR Bond Sustainable (EUR) (the "Merging Sub-Fund") into UBS (Lux) Bond SICAV – Short Term EUR Corporates Sustainable (EUR) (the "Receiving Sub-Fund") (both subfunds collectively referred to as the "Sub-Funds") on 26 September 2023 (the "Effective Date") (the "Merger").
