that Credit Suisse Asset Management (Schweiz) AG, acting as Investment Manager of the Subfunds, will merge into UBS Asset Management Switzerland AG (the "Merger"). The Merger is expected to be effective on **30 August 2024** (the "Effective Date"). Upon the Effective Date, Credit Suisse Asset Management (Schweiz) AG will cease to exist and UBS Asset Management Switzerland AG, as surviving entity, will act as Investment Manager of the Subfunds. The Prospectus of the Company will be updated within 3 months of the Effective Date.

For the avoidance of doubt, the Merger will not result in any change to the applicable fees nor to the investment policy of the Subfunds.

Capitalised terms used in this notice but not defined herein shall have the meaning ascribed to them in the Prospectus dated 5 July 2024 and the Articles of Incorporation dated 20 September 2018.
