Dear Shareholder.

We are writing to you as a shareholder of the Company ("**Shareholder**") to inform you of the following upcoming changes to the Fund.

Capitalised terms used herein, unless otherwise defined, shall have the same meaning as given to them in the prospectus of the Company (the "**Prospectus**").

## 1. SFDR Reclassification

The Fund is currently classified as an article 6 product under Regulation (EU) 2019/2088 of the European Parliament and of the Council of 27 November 2019 on sustainability related disclosures in the financial services sector ("SFDR") and it is now intended to re-classify the Fund as an article 8 product under SFDR.

It is important to note that the re-classification of the Fund, as described above, does not impact the existing investment objective and policy of the Fund. The Fund will continue to be passively managed by tracking the relevant benchmark as disclosed in the supplement of the Fund (the "**Supplement**").

## 2. Name Change

In addition, the name of the Fund will be updated to the "New Name" as set out in the table below to align with a corresponding change to the name of the relevant benchmark being tracked by the Fund.

## 3. Effective Date

The proposed changes above will enter into force on or around 16 December 2024, subject to the approval of the Central Bank of Ireland (the "Central Bank"). On approval from the Central Bank, the updated Supplement, together with the updated Key Investor Information Documents (KIIDs) and PRIIPs Key Information Documents (KIDs) for the Fund, will be available free of charge at the Company's registered office at 2<sup>nd</sup> Floor, 5 Earlsfort Terrace, Dublin 2, Ireland and online at <a href="https://www.ubs.com/etf">www.ubs.com/etf</a>, and/or free of charge from the local representatives in the countries where the Company is registered, including in Switzerland from UBS Fund Management (Switzerland) AG, Aeschenplatz 6, 40552 Basel, Switzerland, which acts as Swiss Representative, and UBS Switzerland AG, Bahnhofstrasse 45, CH-8090 Zurich, Switzerland, which acts as the Swiss Paying.
