#### **c) Location where the relevant documents of the Fund may be obtained**

The prospectus, the key information document (PRIIPs-KID), the management regulation, as well as the annual and semi-annual reports of the Fund may be obtained free of charge from the representative of the Fund.

#### **d) Publications**

Publications concerning the Fund are made in Switzerland on the electronic platform [www.swissfunddata.ch](http://www.swissfunddata.ch).

Each time units are issued or redeemed, the issue and the redemption prices or the net asset value with a reference stating "excluding commissions" must be published for all unit classes on the electronic platform [www.swissfunddata.ch](http://www.swissfunddata.ch).

Prices must be published each working day.

#### **e) Payment of retrocessions and rebates**

The management company and its agents may pay retrocessions to remunerate the activity of promoting the sale of units of the Fund in or from Switzerland. This remuneration may be deemed payment for the following services in particular:

- provision of sales force to the sale promoter and setting up of processes for the subscription of units of the Fund ;
- training of client advisors ;
- production of marketing documents ;
- investor needs analysis ;
- fulfilment of duties of diligence in areas such as money laundering and sale restrictions (e.g. US persons) ;
- assignment and oversight of sub-distributors, if any.

Retrocessions are not considered to be rebates, even if they are ultimately paid out in full or in part to investors.

Information on the payment of retrocessions is governed among others by the relevant provisions of the Federal Act on Financial Services (FinSA).

The management company and its agents do not grant any rebates when promoting sales in or from Switzerland to reduce the commissions and costs accruing to investors and charged to the Fund.

#### **f) Place of performance and jurisdiction**

In respect of the units of the Fund offered in Switzerland, the place of performance is the registered office of the representative. The place of jurisdiction is at the registered office of the representative or at the registered office or place of residence of the investor.

### **Report on activities of the Board of Directors of the Management Company**

#### **DMC FUND - WORLD HY CORPORATE BONDS**

The investment objective of the DMC FUND - WORLD HY CORPORATE BONDS Sub-Fund is to achieve a long-term capital increase, by offering to investors access to the global "high yield" corporate bonds. The management is based on a quantitative approach, called optimized sampling approach, aimed to align the principal portfolio risk factors with those of the benchmark with the most efficient bonds. The global control of portfolio risk is achieved using quantitative process centered on spread maximization procedure, subject to multiple constraints derived from the benchmark risk profile and structure.

The DMC FUND - WORLD HY CORPORATE BONDS was launched on 15th October 2019. Six units were issued in USD, EUR and CHF for institutional and retail investors. Units I-USD and R-USD were issued at an initial price of USD 1,000 units I-EUR and R-EUR were issued at an initial price of EUR 1,000 and units I-CHF and R-CHF were issued at an initial price of CHF 1,000. As of 31st December 2023, the Net Asset Value stood at USD 1,138.05 for units I-USD, USD 1,118.70 for units R-USD, EUR 1,051.47 for units I-EUR, EUR 1,033.79 for units R-EUR, CHF 1,009.11 for units I-CHF and CHF 991.75 for units R-CHF.

#### **The performance of the Sub-fund**

From 31st December 2022 to 31st December 2023, the USD shares posted a total return of 11.5 % for the units I and 11.1 % for the units R, while the ICE Merrill Lynch Global High Yield Index rose by 13.1 % in USD unhedged terms. The I-EUR units gained 8.7 % and the R-EUR units gained 8.3 %, while the benchmark rose 10.3 % in EUR hedged terms. The I-CHF units gained 6.3% and the R-CHF units rose 6.0%, while the CHF hedged benchmark gained 8.0%. The gap observed over the last year result mostly from fees and transaction costs stemming from the implementation of amended ESG criteria.

#### **Economic review & outlook**

High yield corporate bonds staged an impressive rebound in 2023, recouping much of the losses incurred during the sell-off in 2022. Most of the gains came in the last two months of 2023, as macroeconomic developments led both investors and central bankers to reassess the need to keep policy rates "higher for longer" to bring inflation under control. During this period, the yield on the 10-year US Treasury note fell from a high of nearly 5% to less than 4%, and credit spreads tightened significantly. The faster-than-expected slowdown in inflation fueled hopes for a "soft landing" of the US economy and a "dovish" pivot by both the US Federal Reserve and the European Central Bank. In support of this scenario, US central bankers have released projections that place the Fed Funds rate between 4.5% and 4.75% by the end of 2024.

High Yield corporate bonds outperformed all other fixed-income segments in 2023 thanks to the large excess in yields at the beginning of period and the significant compression in credit risk premia that took place in 2023. This decline was fueled by the surprising vigor of the US economy in the second half of the year. Default rates increased somewhat, but remained contained by historical standards. The prospects for 2024 look favourable as yields are still high attractive. High Yield corporate bonds exhibit fair valuation under the assumption of "soft landing" and preemptive easing in monetary policy. Meager supply and solid demand for High Yield corporate bonds should further support this segment in the absence of unexpected shock or recession.

## Audit report

### Our opinion

In our opinion, the accompanying financial statements give a true and fair view of the financial position of DMC Fund (the "Fund") as at 31 December 2023, and of the results of its operations and changes in its net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements.

#### *What we have audited*

The Fund's financial statements comprise:

- the Combined statement of net assets for the Fund and the statement of net assets for the sub-fund as at 31 December 2023;
- the Combined statement of operations and other changes in net assets for the Fund and statement of operations and other changes in net assets for the sub-fund for the year then ended;
- the Statement of investments and other net assets of the sub-fund as at 31 December 2023; and
- the notes to the financial statements, which include a summary of significant accounting policies.

### Basis for opinion

We conducted our audit in accordance with the Law of 23 July 2016 on the audit profession (Law of 23 July 2016) and with International Standards on Auditing (ISAs) as adopted for Luxembourg by the "Commission de Surveillance du Secteur Financier" (CSSF). Our responsibilities under the Law of 23 July 2016 and ISAs as adopted for Luxembourg by the CSSF are further described in the "Responsibilities of the "Réviseur d'entreprises agréé" for the audit of the financial statements" section of our report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

We are independent of the Fund in accordance with the International Code of Ethics for Professional Accountants, including International Independence Standards, issued by the International Ethics Standards Board for Accountants (IESBA Code) as adopted for Luxembourg by the CSSF together with the ethical requirements that are relevant to our audit of the financial statements. We have fulfilled our other ethical responsibilities under those ethical requirements.

### Other information

The Board of Directors of the Management Company is responsible for the other information. The other information comprises the information stated in the annual report but does not include the financial statements and our audit report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.



In connection with our audit of the financial statements, our responsibility is to read the other information identified above and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

#### **Responsibilities of the Board of Directors of the Management Company for the financial statements**

The Board of Directors of the Management Company is responsible for the preparation and fair presentation of the financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements, and for such internal control as the Board of Directors of the Management Company determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors of the Management Company is responsible for assessing the Fund's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors of the Management Company either intends to liquidate the Fund or to cease operations, or has no realistic alternative but to do so.

#### **Responsibilities of the “Réviseur d'entreprises agréé” for the audit of the financial statements**

The objectives of our audit are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an audit report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Law of 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with the Law of 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;
- obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Fund's internal control;
- evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Board of Directors of the Management Company;



- conclude on the appropriateness of the Board of Directors of the Management Company's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Fund's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our audit report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our audit report. However, future events or conditions may cause the Fund to cease to continue as a going concern;
- evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

#### **Note 1 - General Information**

DMC FUND (the "Fund") was initially set up on 3rd April 1998 (under the name DYNAMIC FLOORING FUND) as an open-ended mutual fund governed by Luxembourg Law and investing in marketable transferable securities. DMC FUND as a Luxembourg mutual Fund (*Fonds commun de placement*) is governed by part I of the Luxembourg Law on Undertakings for collective Investment of 17th December 2010, as amended.

Financial reports of the Fund are published annually and semi-annually. Both reports will be sent free of charge to unitholders making a request in writing and are available to unitholders at the offices of the Management Company, the Administration Agent and at the Representative and Paying Agent in Switzerland.

The KID ("Key Information Document") is available free of charge at the registered offices of the Depositary and of the Management Company and at the Representative in Switzerland.

#### **Note 2 - Significant accounting policies**

##### a) Presentation of the financial statements

The financial statements of the Fund are established in accordance with the Luxembourg legal and regulatory requirements concerning Undertakings for Collective Investment and with generally accepted accounting principles in Luxembourg.

The financial statements of the Fund have been prepared on a going concern basis.

An indicative Net Asset Value ("NAV") has been determinated on 31st December 2023 for the preparation of these financial statements.

##### b) Valuation of assets

1. Calculation is done on the basis of the closing stock exchange prices on the business day preceding the Valuation Day i.e. securities quoted on an official Stock Exchange or any other market, are valued on the basis of the closing price as of the business day preceding the valuation day, and, if there are several markets, the closing price of the Stock Exchange which is the principal market for the security in question, unless these prices are not representative.
2. For unlisted securities, and for quoted securities for which the closing price on the Business day preceding the Valuation Day is not representative, valuation is based on the reasonable foreseeable sales price estimated prudently and in good faith by the Management Company.
3. Liquid assets are assessed at their nominal value plus accrued interest.
4. Assets denominated in other currencies than the base currency of the Sub-Fund is translated into that base currency at the mid rates of these currencies on the Business day preceding the Valuation Day (snapshot Reuters at 5:00 PM Luxembourg time).
5. The Management Company is authorised to adopt other realistic valuation principles for assets of the Fund where circumstances make the determination of values according to the criteria specified above non-realistic, impossible or inadequate. Especially in case of major changes in market conditions, the valuation basis of the different investments may be adjusted to the new market yields.

6. The value of units representing any open-ended undertakings for collective investment is determined using the last official Net Asset Value per unit or the last Net Asset Value estimate if this value is more recent than official Net Asset Value, provided that the Company is guaranteed that the valuation method used for this estimate is consistent with that used for the calculation of the official Net Asset Value.

c) Acquisition cost of securities in the portfolio

The acquisition cost of the securities held by the Sub-Fund that are denominated in currencies other than the reference currency of the Sub-Fund is converted into this currency at the exchange rates prevailing on the date of purchase.

d) Net realised gain/(loss) on securities portfolio

The realised gains and losses on the securities portfolio are calculated on the basis of the average acquisition cost and are disclosed net in the statement of operations and other changes in net assets.

e) Investment portfolio income

Dividend income is recorded at the ex-date, net of any withholding tax.

Interest income accrued is recorded, net of any withholding tax.

f) Return on Sukuk

Sukuk are certificates of investments or securities representing the rights and obligations of its holders on an underlying asset. Their remuneration (which is capped) is based on performance of the assets. The remuneration of sukuk is variable depending on the profits earned on the assets or on the income of the issuer.

g) Valuation of forward foreign exchange contracts

Open forward foreign exchange contracts are valued at forward market rates for the remaining period from valuation date to the maturity of the contracts. Realised gains and losses on forward foreign exchange contracts correspond to the difference between the value of the contract at the time its opening and its closing value. Net unrealised gains or losses of open contracts are disclosed in the statement of net assets. Net variation of the unrealised gains or losses and net realised gains or losses are disclosed in the statement of operations and other changes in net assets.

h) Conversion of foreign currencies

Cash at banks, other net assets, liabilities and the market value of the securities in portfolio expressed in currencies other than the reference currency of the Sub-Fund are converted into this currency at the exchange rates prevailing on the date of the financial statements.

Income and expenses expressed in currencies other than the reference currency of the Sub-Fund are converted into this currency at the exchange rate prevailing on the date of the transaction. Net realised gains or losses on foreign exchange are disclosed in the statement of operations and other changes in net assets.

i) Combined financial statements

The combined financial statements of the Fund are expressed in EUR and are equal to the corresponding items in the financial statements of the Sub-Fund converted into this currency at the exchange rate prevailing at the date of the financial statements.

#### j) Transaction fees

Transaction costs disclosed under the item "Transaction fees" in the expenses of the statement of operations and other changes in net assets are mainly composed of broker fees incurred by the Fund and of fees relating to transactions paid to the Depositary as well as of transaction fees on financial instruments and derivatives.

#### k) Revaluation difference

The item "Revaluation difference" in the combined statement of operations and other changes in net assets represents the valuation difference of the net assets at the beginning of the financial year of the Sub-Fund converted into the reference currency of the Fund with the exchange rates applicable at the beginning of the financial year and the exchange rates applicable at the end of the financial year.

#### l) Receivable / Payable on treasury transactions

The item "Receivable on treasury transactions" comprises maturities of time deposits, new loans, foreign exchange transactions or forward foreign exchange transactions not yet disclosed under the item "Cash at banks".

The item "Payable on treasury transactions" comprises new time deposits, maturities of loans, foreign exchange transactions or forward foreign exchange transactions not yet disclosed under the item "Cash at banks".

At the level of the Sub-Fund, "Receivable and payable on treasury transactions" are disclosed net in the statement of net assets.

### **Note 3 - Management Company fees**

#### 1) All-in fee

The Management Company receives from the Fund an annual all-in fee, except for brokerage fees and bank charges normally payable on transactions relating to the portfolio of the relevant Sub-Fund, calculated on the average net assets of the relevant month, payable monthly.

- the annual "*taxe d'abonnement*" calculated on the NAV of each Sub-Fund and payable quarterly on each unit class (0.05% for the unit R and 0.01% for the unit I),
- cost relating to subscription taxes, records, deposit and other requirements concerning the Fund by all foreign authorities or stock exchanges,
- advertising costs or other expenses directly connected with the offering of distribution of units, including the costs of printing and copying of the documents mentioned above or reports used by distributors of units in their commercial activity.

#### **Note 4 - Commissions on subscription and on redemption**

The caption "Commissions on subscription and on redemption" in the statement of operations and other changes in net assets comprises the dilution levy and the commissions received on subscriptions and on redemptions.

##### **a) Dilution levy**

As stipulated in the prospectus of the Fund, all subscriptions / redemptions / conversions of units of the Sub-Fund are submitted to a dilution levy applied on the subscribed amount in order to offset spreads on bonds prices. The dilution levy is paid into the Sub-Fund and becomes part of the Sub-Fund's assets. The dilution levy does not exceed 1.50% of the subscribed amount.

However under exceptional circumstances such as periods of crisis which render necessary a higher percentage, and always when it is in the best interest of the unitholders of the Sub-Fund, the Board of Directors of the Management Company is entitled to fix the dilution levy at a percentage higher than 1.50% of the subscribed amount.

The Board of Directors of the Management Company decided by circular resolution dated 13th January 2023, with effect from 17th January 2023 to increase the effective rate of the dilution levy to 0.50% (previous effective rate: 0.40%), which will be deducted from the amounts of subscriptions and redemptions. This rate may be reviewed in the light of the market situation, based on the decision of the Investment Manager. These changes do not affect the maximum rates mentioned in the prospectus.

The dilution levy was not applied on 31st December 2023.

##### **b) Commission on units issued and redeemed**

The issue price of units of the Sub-Fund is equal to the NAV per unit, increased by a front-end sales charge of up to 5.10% of the NAV, which may be waived in whole or in part, and which, if applicable, has to be paid to the Management Company, except for the portion of 0.10% which is payable to the relevant Sub-Fund to contribute to the transaction costs of investing the net subscription proceeds.

The Management Company can pay reimbursements of the front-end sales charge to institutional investors and to distributors and grant trailer fees to a wider circle of sales agents/partners.

The price to be paid in respect of each unit tendered for redemption (the "Redemption Price") is the NAV per unit.

The Board of Directors of the Management Company decided by circular resolution dated 13th January 2023, with effect from 17th January 2023 to stop levying front-end sales (previous effective rate: 0.10%).

#### Note 5 - Total expense ratio ("TER")

The TER disclosed under "Statistical information" of this report is calculated in accordance with the "Guidelines on the calculation and disclosure of the TER of collective investment schemes" issued on 16th May 2008 and amended on 5th August 2021 by the Asset Management Association Switzerland.

The TER is calculated for the last 12 months preceding the date of this report.

Transaction fees are not considered in the calculation of the TER.
