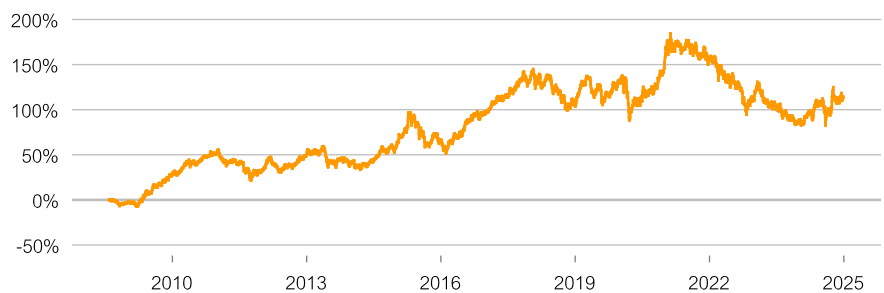

The fund management seeks to identify investments with attractive valuations and shareholder-friendly corporate policies such as capital returns and share buybacks (total shareholder return). The fund allocation is independent of market benchmark and uses decades of experience and in-depth Asian expertise of the DJE research team to deliver a positive performance.

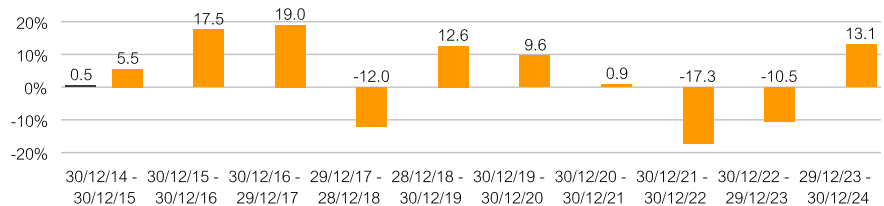
Performance in % since inception (01/08/2008)

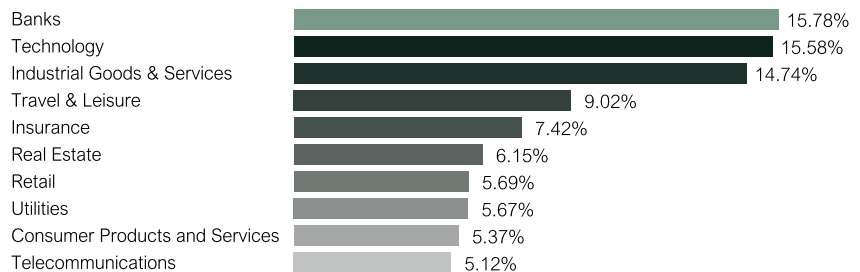

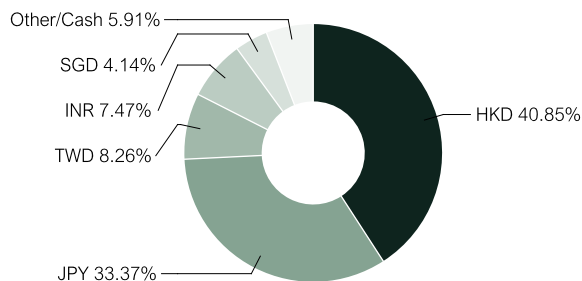

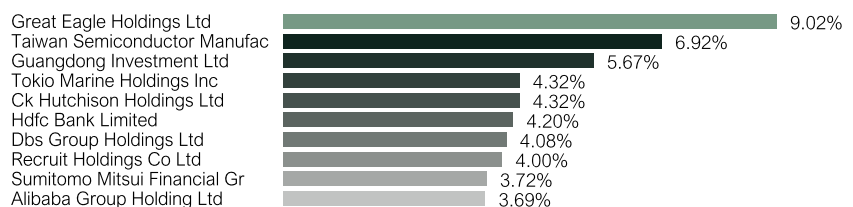

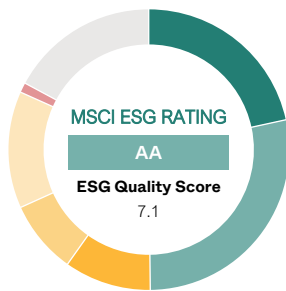

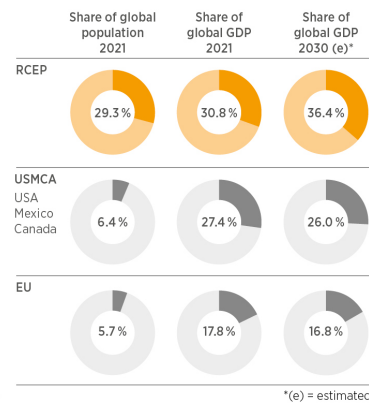
AAA, AA	Leader: The companies that the fund invests in show strong and/or improving management of financially relevant environmental, social and governance issues. These companies may be more resilient to disruptions arising from ESG events.
A, BBB, BB	Average: The fund invests in companies that show average management of ESG issues, or in a mix of companies with both above-average and below-average ESG risk management.
B, CCC	Laggard: The fund is exposed to companies that do not demonstrate adequate management of the ESG risks that they face, or show worsening management of these issues. These companies may be more vulnerable to disruptions arising from ESG events.

Investment Approach

DJE - Asien invests primarily in companies with attractive and promising business models from the Asia-Pacific region. The RCEP (Regional Comprehensive Economic Partnership) free trade zone, which was established in 2020, is the largest in the world in terms of its share of global GDP and is expected to contribute to the region's dynamic growth (see chart). The fund's allocation is based on our proprietary, fundamental, top-down (FMM methodology) and bottom-up analysis. We believe that the combination of global macroeconomic analysis along with bottom-up security selection is essential to balance opportunities and risks. The focus of the fund is companies with attractive revenue and earnings growth, stable earnings, potential for innovation and a leading competitive position. The fund management allocates across regions, countries, and sectors of the Asian economic area, independent from any market benchmarks.

Monthly Commentary

Asian stock markets performed differently in December. While the markets in China and Hong Kong recorded price gains, the stock exchanges in Japan, India, Indonesia and Korea fell. In China, the government announced additional measures to boost domestic demand and consumption. To this end, the budget deficit is expected to be increased and interest rates and banks' minimum reserve ratios lowered. By strengthening domestic demand in this way, the Chinese government is attempting to counter the risks posed by the expected increase in US import tariffs on Chinese goods. It remains to be seen whether these measures will be sufficient to mitigate the effects of a deteriorating environment. Against this market backdrop, the DJE - Asien gained 2.47%. At sector level, the picture was mixed in December. The sectors that performed best in relative terms were Construction & Materials (underweighted in the fund), Consumer Staples (underweighted in the fund) and Energy (underweighted in the fund). The sectors that performed the worst in relative terms were Consumer Discretionary (overweight in the fund), Industrials (overweight in the fund) and Technology (underweight in the fund). Overall, the sector weighting therefore had a negative impact on the fund's price performance relative to the market. At individual stock level, the highest performance contributions in December came from Guangdong Investment (utilities), TSMC (semiconductors) and Tencent (internet conglomerate). On the other hand, Hon Kwok Land Investment (property), KB Financial Group (bank) and Japan Post Holdings (banking, insurance and logistics conglomerate), among others, had a negative impact. The overweight was increased in the utilities, consumer goods, industrial goods & services and insurance sectors. The overweight was reduced in the banking, retail, travel and leisure, chemicals and property sectors. The underweight was reduced in the financial services sector. The investment ratio rose from 90.49% to 98.66%.
