Investment Strategy

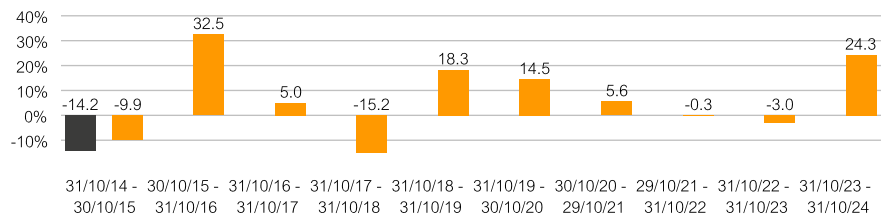
DJE - Gold & Ressourcen PA is a thematic global equity fund. The concentrated portfolio of 50-70 stocks focuses on companies that are involved in the mining, processing and marketing of gold. Equities from the broader commodities universe, such as diversified mining companies, non-ferrous metals, oil and gas, can also be added for further diversification. The investment strategy is completely independent of any benchmark requirements and the share of gold mining stocks can vary between 30 and 100%. With gold as the investment focus, the fund offers diversification and a lower correlation to traditional investment strategies.

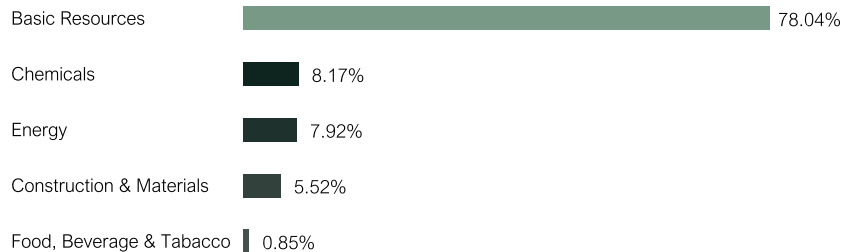

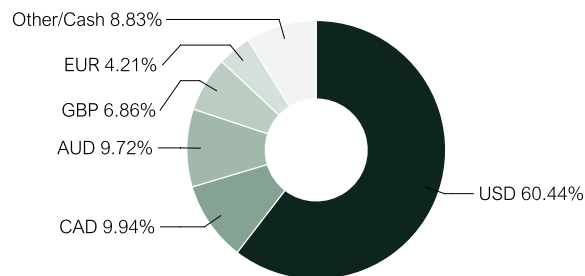

Top 10 Equity Sectors in % of Fund Volume



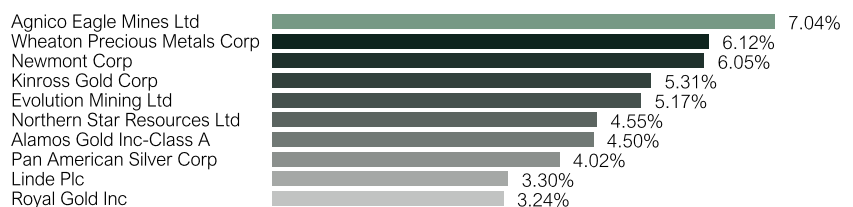

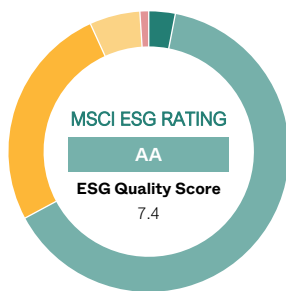

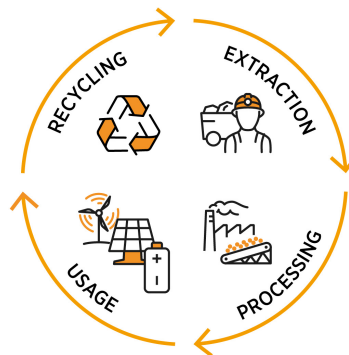
ESG Rating What it means

Investment Approach

The thematic and globally investing equity fund focuses on gold and precious metals, diversified commodity groups, base metal producers, chemical companies and oil & gas producers. The fund pursues a bottom-up approach with high-quality stock selection, focusing on the fundamental key financial indicators of the companies. We invest primarily in gold producers with a competitive cost structure that generate free cash flows even at lower gold prices. In general, negative or falling real interest rates are positive for tangible assets, particularly gold. Demand for gold is likely to rise if real interest rates are low or fall.

Opportunities

- + In the long term, high upside potential for stocks of the gold and commodity sector
- + Exchange rate gains in global investments are possible
- + Increasing demand for physical gold due to declining confidence in established currencies and high demand from the emerging market jewellery sector; this should lead to higher gold prices and thus to higher prices for gold mining stocks

Monthly Commentary

In October, the DJE - Gold & Ressourcen rose by 3.76%. The XAU gold mining index rose by 1.62% in US dollar terms and by 4.29% in euros due to the strengthening US dollar. Gold mining stocks thus performed worse than the gold price itself. The price of a troy ounce climbed by 4.15% in USD and by 6.55% in euros. The World Gold Council (WGC) has published data on gold demand in the third quarter, with the increase in demand (+5% year-on-year including free trade) being mainly due to gold ETFs, which recorded inflows for the first time in 10 quarters. Central banks continued to increase their gold reserves, but at a slower rate than in previous quarters. Jewelry demand in China suffered due to weak economic development, among other things, whereas in India, jewelry demand and demand for bars and coins rose noticeably due to the reduction in import taxes. China and India together account for around 60% of global jewelry demand. After the gold price gained momentum in the run-up to the US elections, the development could be somewhat more moderate in the short term. However, gold should continue to benefit from the US Federal Reserve's interest rate cut cycle, central bank purchases and global devaluation trading in the coming months. The highest positive performance contributions in October came from positions in the gold mining company Agnico Eagle (Canada), the precious metals trading company Wheaton Precious Metals (Canada) and the silver company Pan American Silver (Canada), among others. In contrast, the positions in the copper companies Antofagasta (Chile) and Freeport McMoran (USA) and the gold mining company Newmont (USA) had a negative impact. The weighting of gold mining stocks was over 60% in the reporting period - which corresponds to an increase on the previous month (almost 59%); The focus remains on solidly financed producers who generate positive free cash flows even at lower gold prices and also have a certain growth perspective. Broader commodity/chemical stocks generally performed weaker than gold mining stocks in October: The MSCI World Materials commodity index fell by -2.45% and the CRB commodity index rose by 0.80% - both index figures are based on EUR.
