

Fund description

- The Fund's portfolio holdings primarily consist of investment funds which either (i) promote environmental (E) and/or social (S) characteristics or (ii) have sustainable investments or reduction in carbon emissions as their objective.
- The Fund invests according to a dedicated asset allocation for a Growth investment strategy which reflects the UBS House View on Sustainable Investing.
- The exchange rate risk between USD and NOK is largely hedged.

The allocation of the Fund investments are expected to be flexibly adjusted in line with prevailing market expectations. The investment funds have been identified following a due diligence process and were selected based on the strength of their investment strategy and how they fit together in a portfolio.
