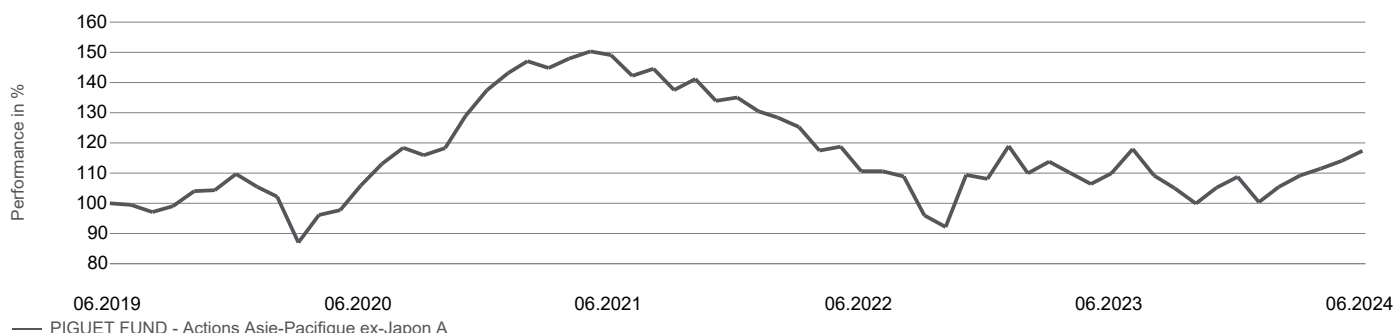
**Ed Yau, CFA, CAIA**

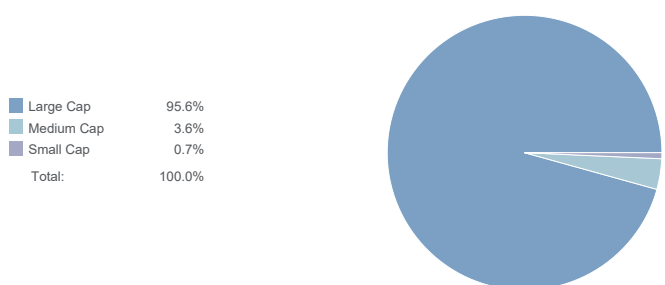

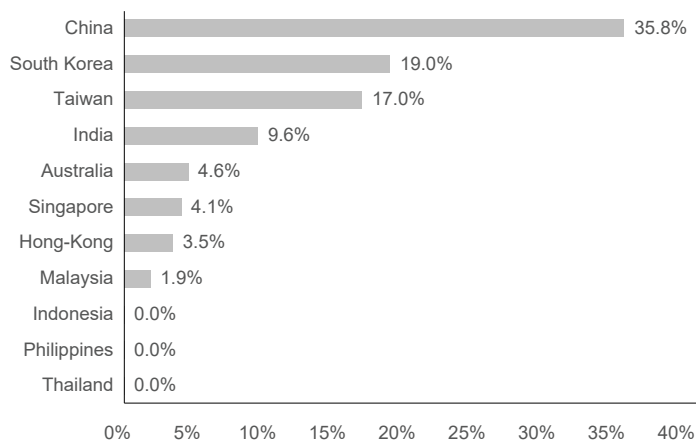
