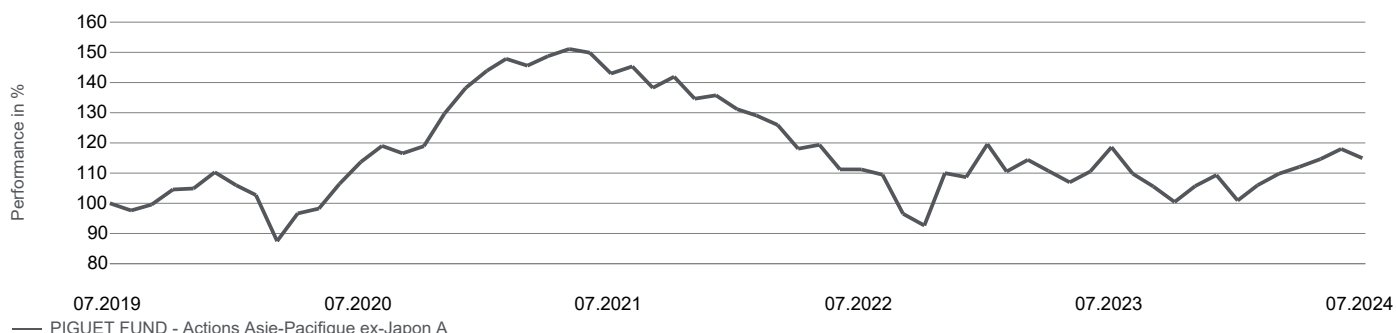
Ed Yau, CFA, CAIA

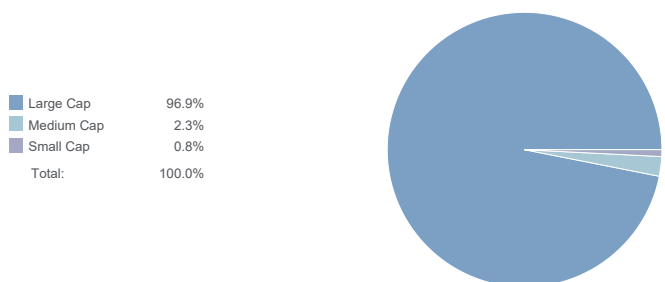

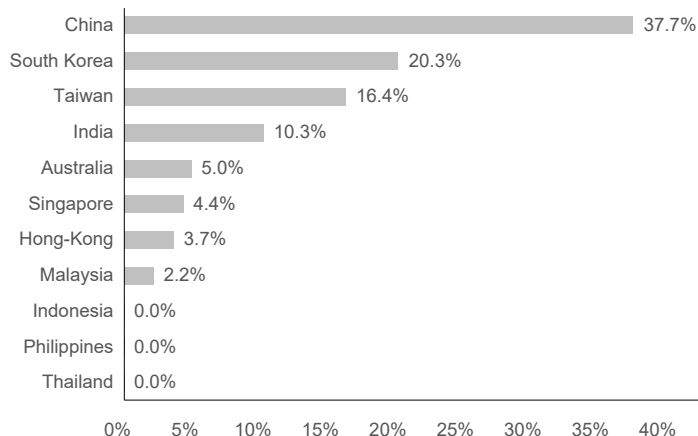
