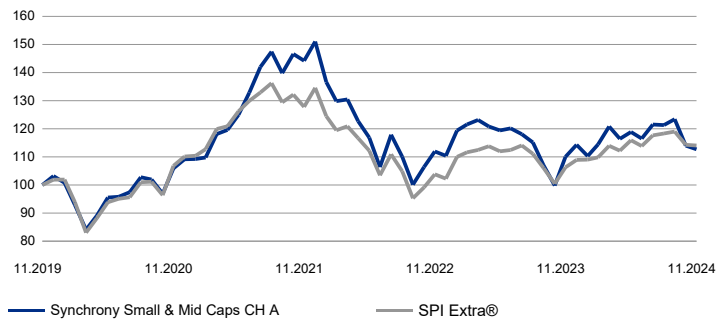

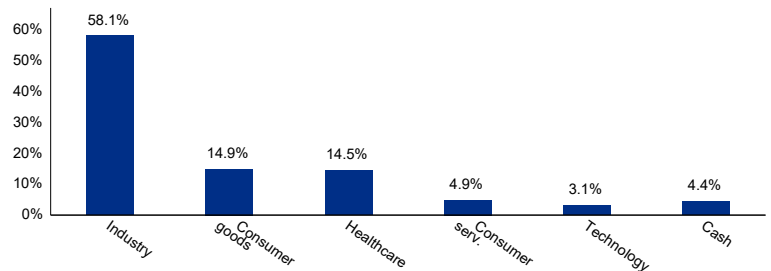

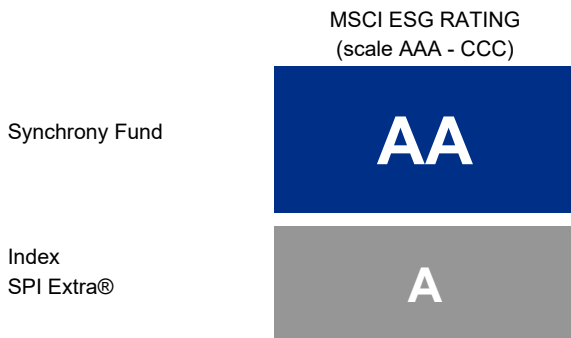

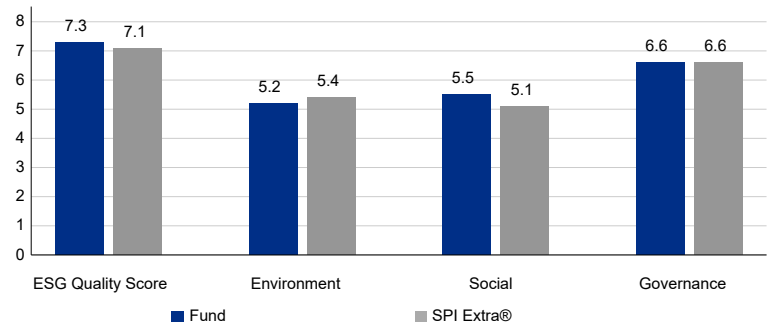

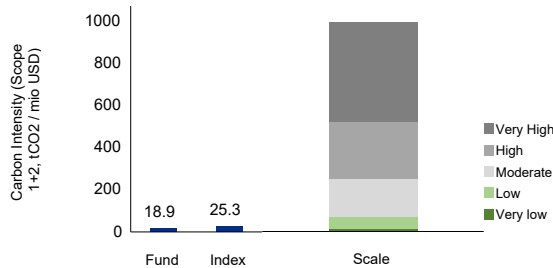
**ESG rating of the portfolio**



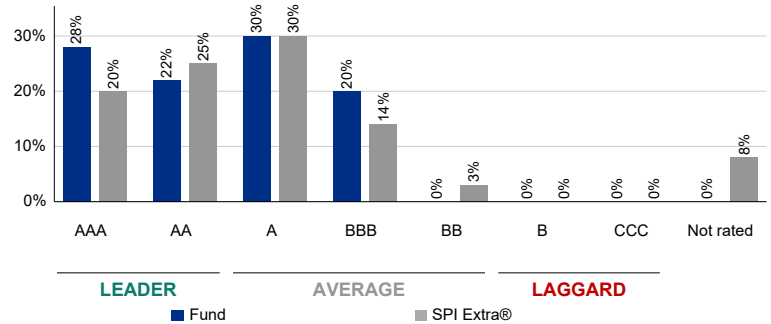
**ESG Quality Score and rating by criteria (scale 1 - 10)**
