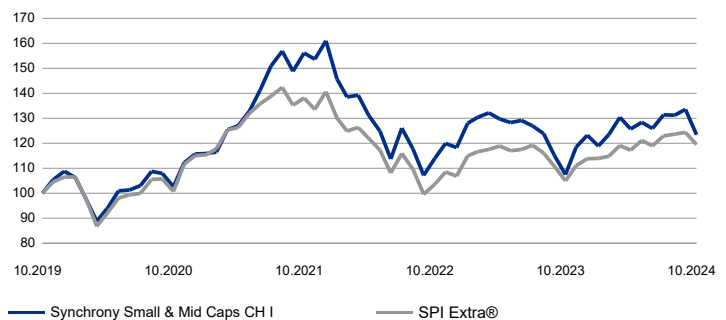

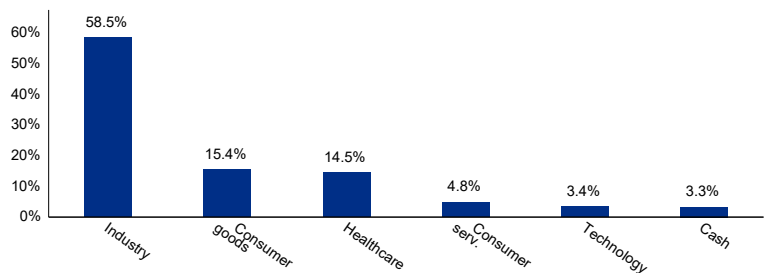

Sector breakdown



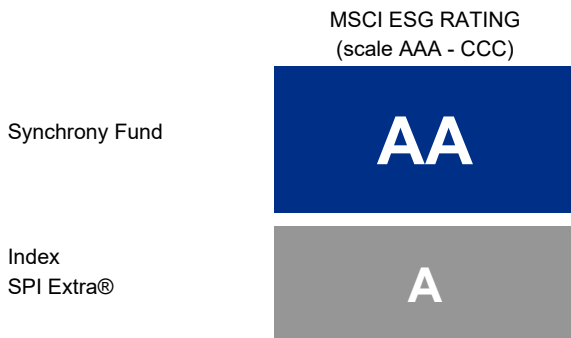

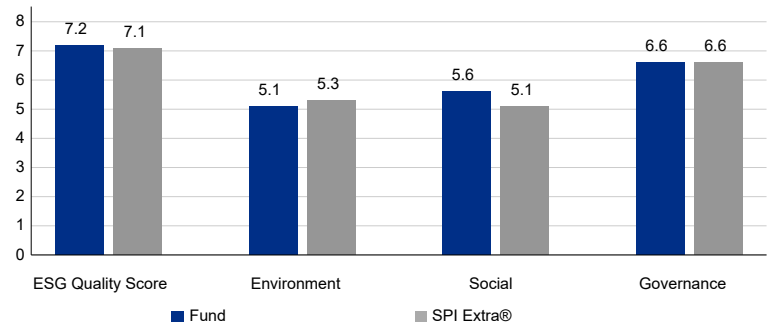

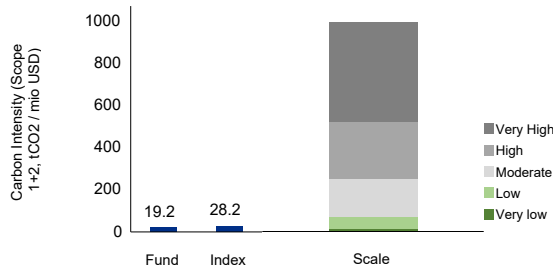
ESG rating of the portfolio



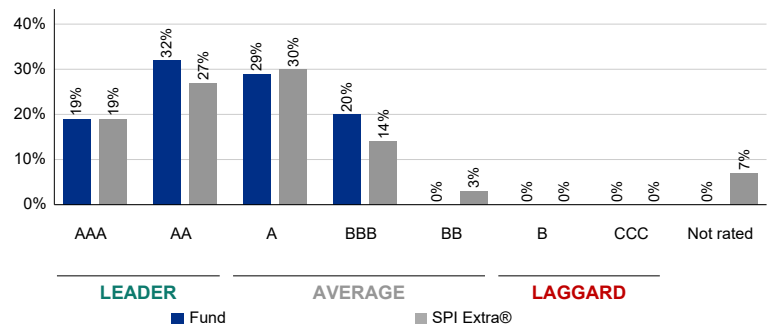
ESG Quality Score and rating by criteria (scale 1 - 10)
