The portfolio is dynamically managed through a comprehensive analysis of the fundamentals of the countries concerned, as well as an evaluation of its maturities and the related interest rate and exchange rate risks. This Fund is intended for investors seeking to diversify their assets into international government bonds with the Swiss franc as their money of reference. Currency risks, however, are not systematically hedged







Currency zone breakdown (%)




Répartition géographique (%)
