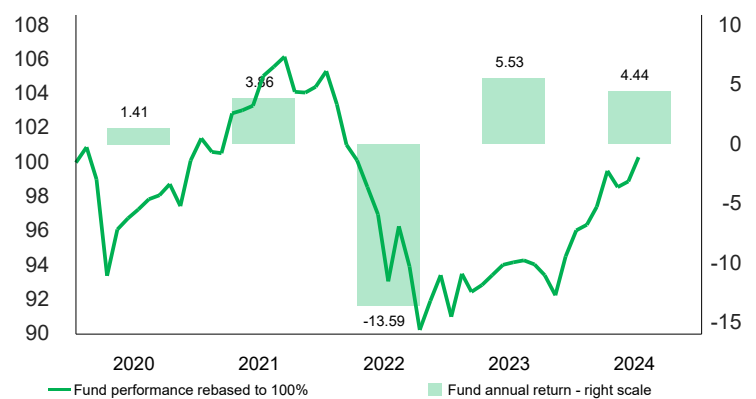

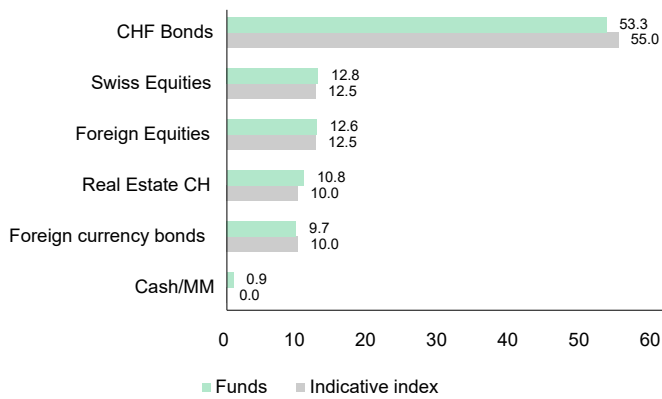
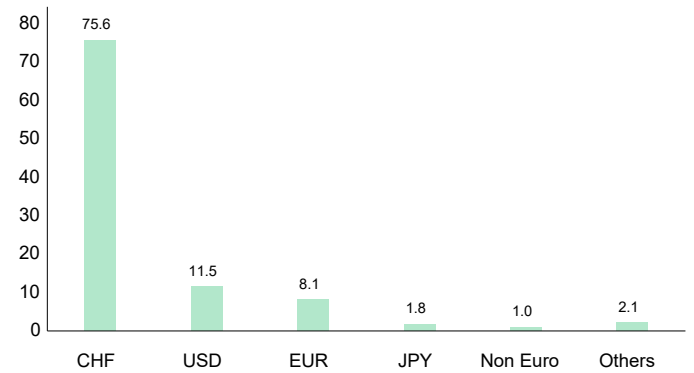
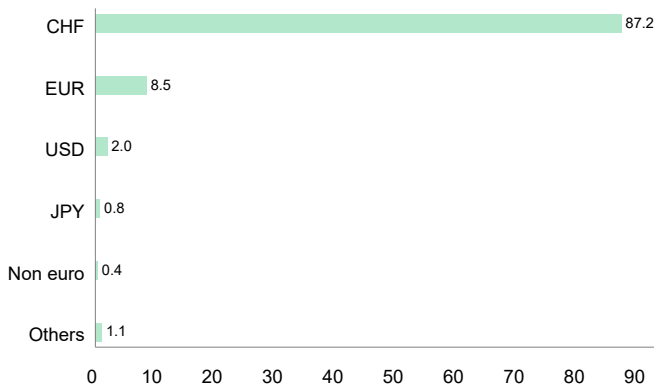
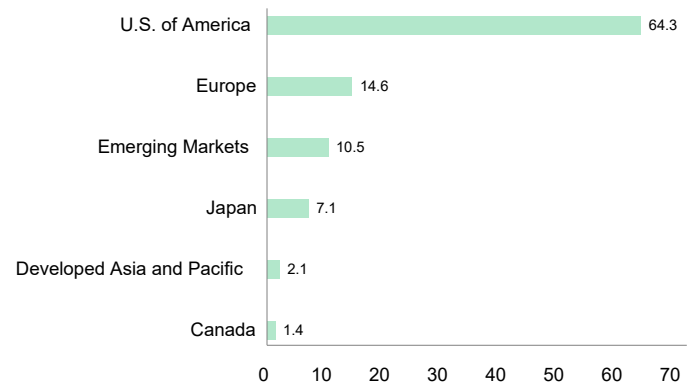


Risk profile
