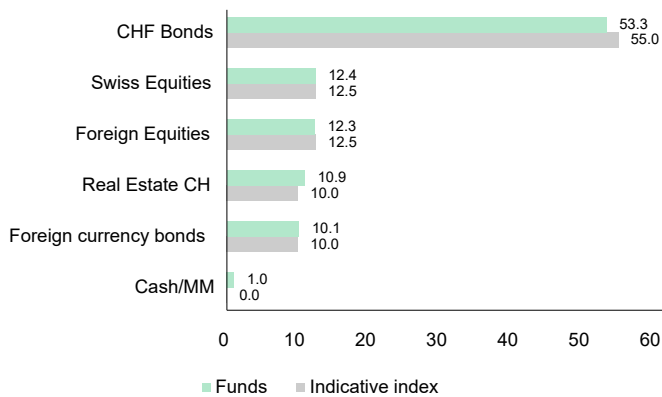
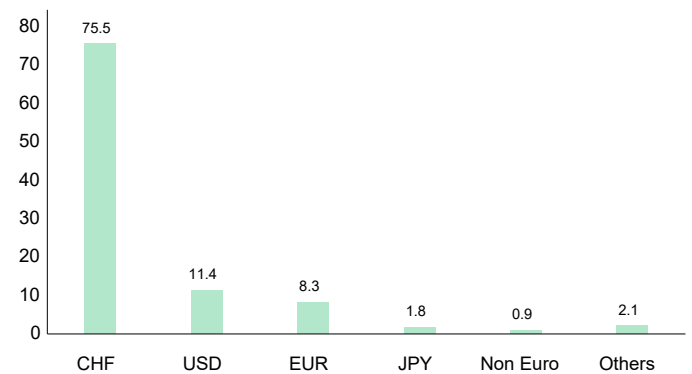
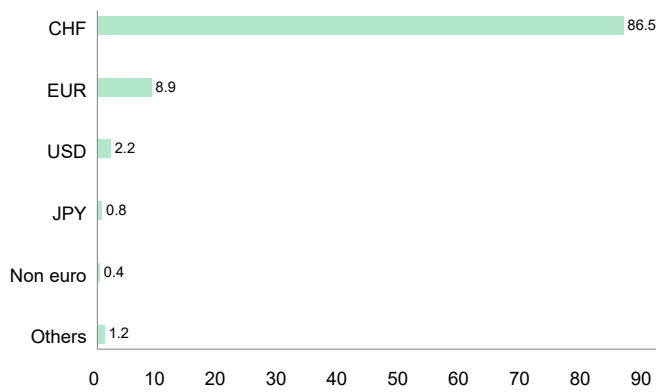
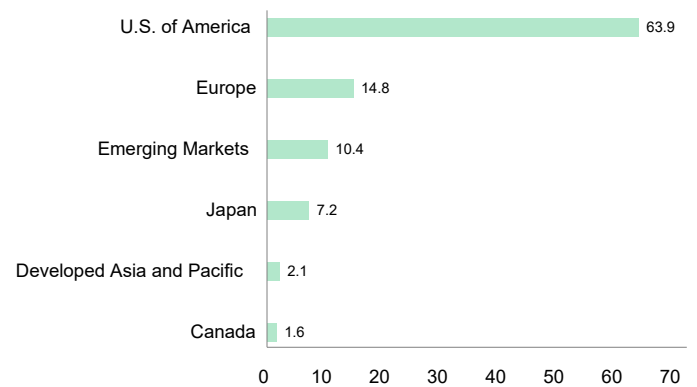


Risk profile
