The Fund is actively managed against the MSCI Emerging Markets Index, investing in large and mid-cap (core) equity securities of companies located in emerging market countries, inclusive of frontier market countries (as defined by MSCI) or deriving substantial revenues from them. The Fund will aim to maintain a maximum of 50% of the weighted average carbon intensity of the benchmark.


# **GEOGRAPHIC BREAKDOWN**
