The Fund is actively managed, primarily investing in euro-denominated corporate debt securities from issuers located around the world. An environmental, social and governance (ESG) framework is applied to investment decisions to assess how ESG activities and attributes are likely to impact the ability of the issuers to repay debt, both now and in the future. Exclusions are used to avoid issuers with the worst ratings from the investment universe and exclude issuers identified by the Investment Manager as undertaking business practices which cause significant environmental or social harm around the world.







GEOGRAPHIC DISTRIBUTION




SECTOR DISTRIBUTION




