The Fund is actively managed, primarily investing in euro-denominated corporate debt securities from issuers located around the world. Exclusions are used to avoid issuers with the worst ratings from the investment universe and exclude issuers identified by the Investment Manager as undertaking business practices which cause significant environmental or social harm around the world.



SECTOR DISTRIBUTION




