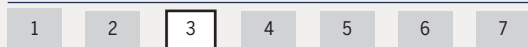

WHAT ARE THE RISKS?

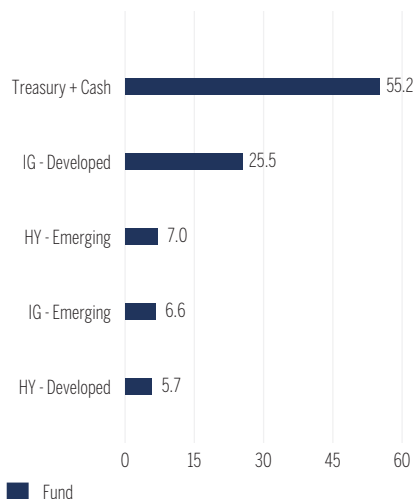

SECTOR DISTRIBUTION

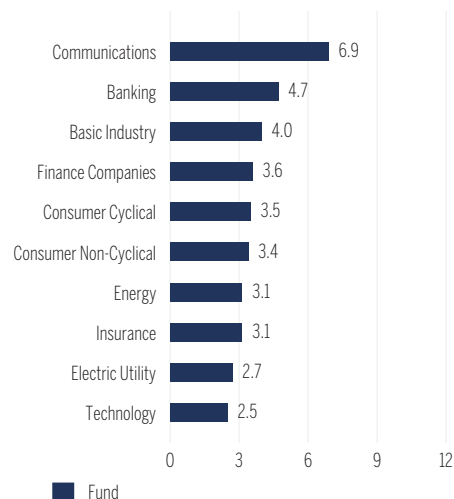
% MARKET VALUE

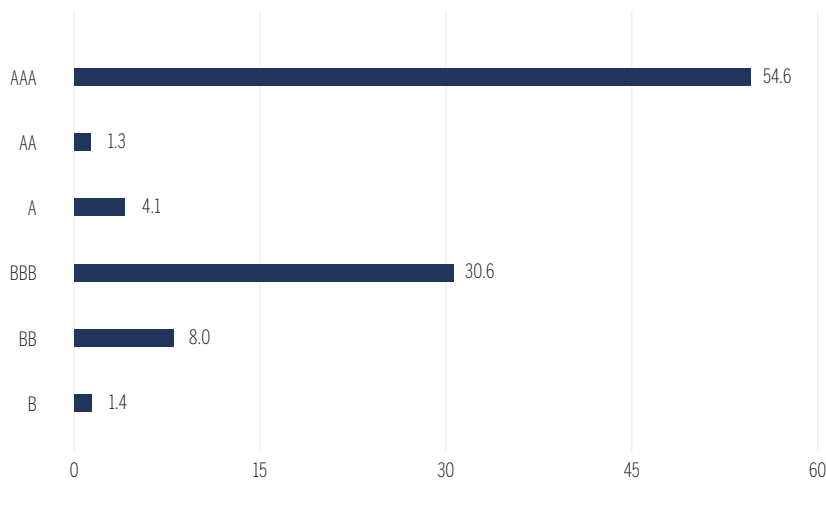
TOP INDUSTRIES EX TREASURIES
