WHAT ARE THE RISKS?

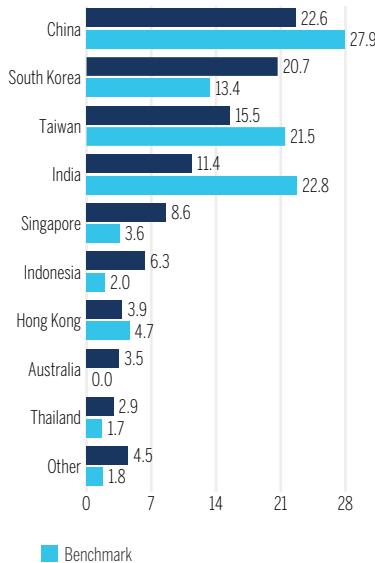

GEOGRAPHIC BREAKDOWN

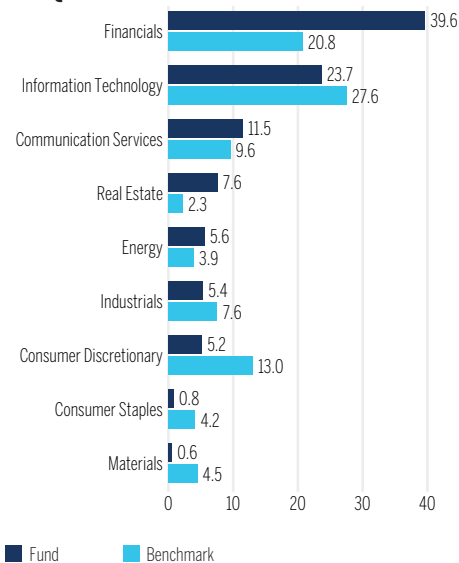
% OF EQUITY
