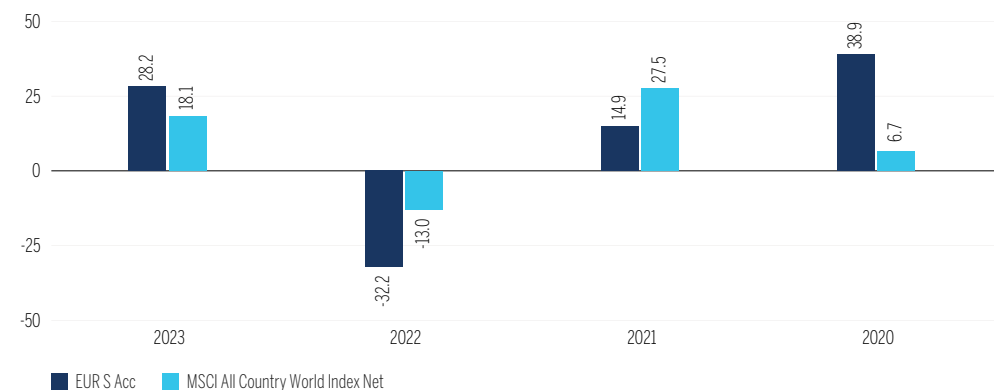

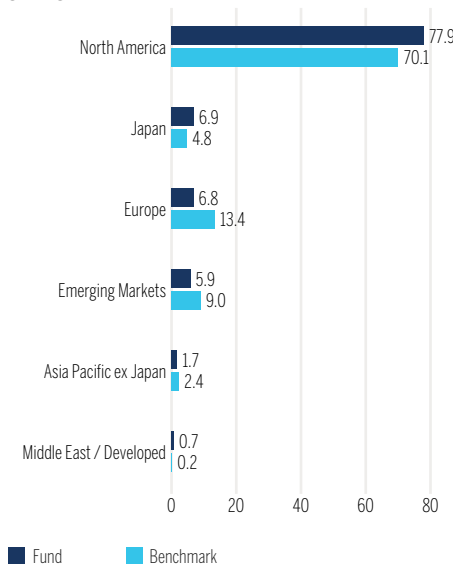

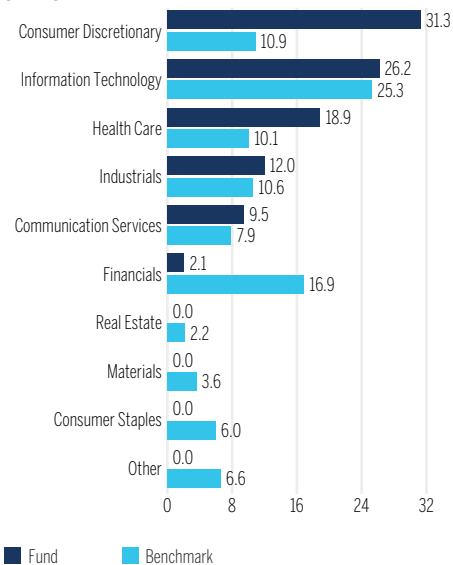
REGIONAL DISTRIBUTION
