Fund Profile

The objective of the Fund is to achieve capital appreciation in the long term by investing in a long-only portfolio of equities and equity-related securities. The Fund invests primarily in a combination of actively managed funds, ETFs as well as single stock positions. Equity derivatives could be employed but their use is expected to be rather limited. The geographic exposure of the Fund is global, but with a core focus on European equity markets. The top-down geographic allocation of the Fund reflects the inputs elaborated by the internal Tactical Asset Allocation Committee whilst bottom-up investment decisions are delegated to the Fund Manager.

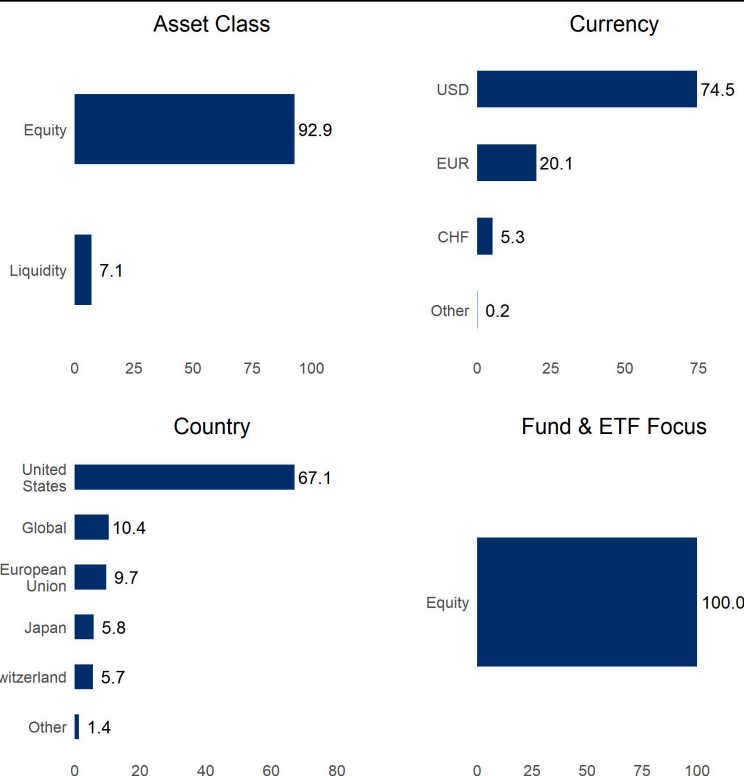

Monthly Commentary

The Fund (share class I-EUR) returned +0.3% in September. September was a particularly volatile month for equities, with expectations leaning negative, as it is historically one of the weakest months of the year. The first week reflected this trend. However, a larger-than-expected interest rate cut by the Federal Reserve and fiscal stimulus announced by the Chinese government provided significant relief to the markets. The MSCI World Index gained 1.7%, while the S&P 500 Index rose by 2.0%, with eight out of eleven sectors recording positive monthly performance. The European market showed mixed results, with the Stoxx Europe 600 slightly down for the month, while the Euro Stoxx 50 rose by nearly 1%. Regarding the Fund's monthly performance, the top three contributors were the Xtrackers MSCI USA Consumer Discretionary UCITS ETF, the SPDR S&P U.S. Communication Services Select Sector UCITS ETF, and the SPDR S&P US Industrials Select Sector UCITS ETF. The bottom three contributors were Adobe, the iShares S&P 500 Health Care Sector UCITS ETF, and the SPDR MSCI Europe Health Care UCITS ETF.
