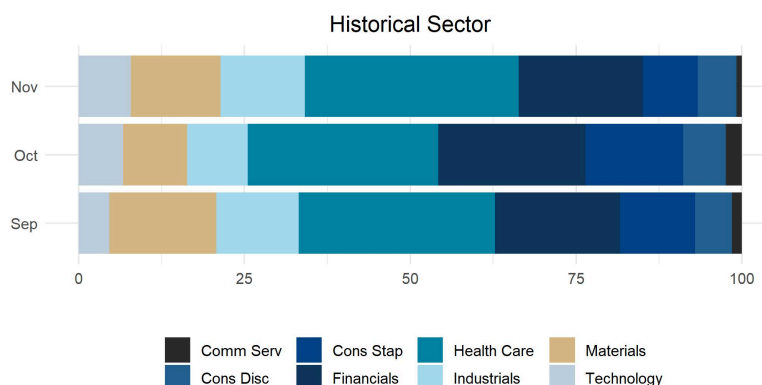
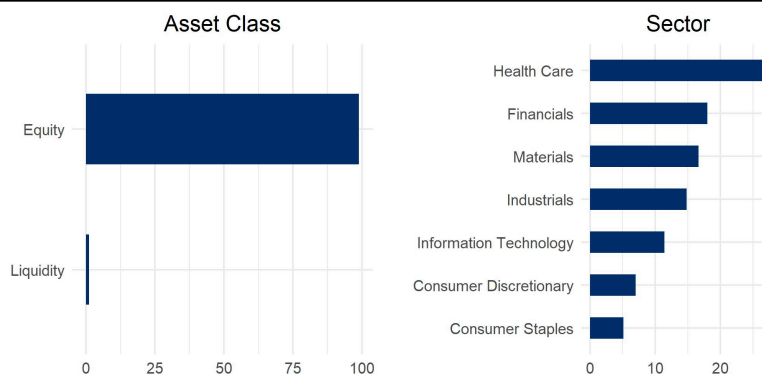

## Monthly Commentary

The Swiss equity market posted a positive performance in December. The Fund overperformed the main index by more than 100 basis points. The Swiss economy continued to be very resilient with an expected +1.2% GDP growth for 2024 and +1.5% in 2025, low inflation, and a robust employment figure. The manufacturing PMI stood below the growth threshold of 50.0 for the twelfth consecutive month, despite a slightly increase of 0.9 points to 43.0. Looking at the Fund composition, we continue to maintain a defensive portfolio structure with a meaningful exposure (~40%) toward the Healthcare and the Consumer Staples sectors as we believe the related earnings may be less impacted by a possible macro-economic slowdown. As far as our top calls are concerned, we have ABB at the first place followed by Givaudan. We also remained constructive on UBS, which has been reiterated in our top 5 calls.
