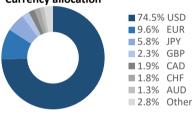

Currency allocation





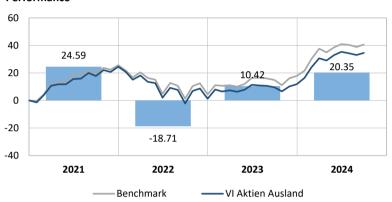


Investment focus and suitability

The individual stock weightings are limited systematically and relative to the index. The fund is targeted exclusively to qualified investors.
