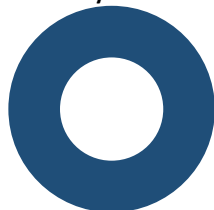

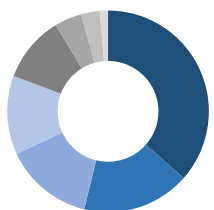

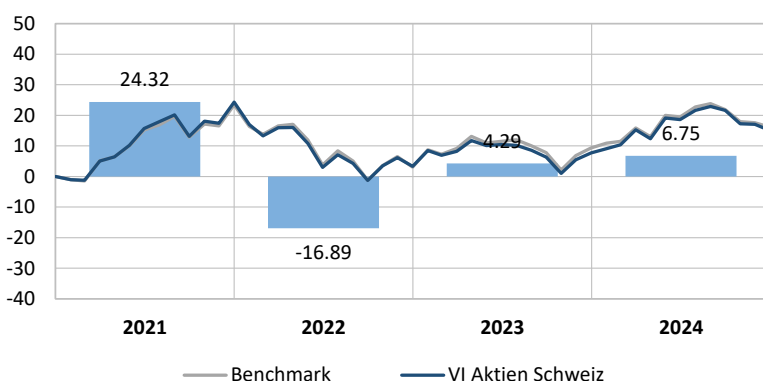
## Investment focus and suitability

The fund invests in Swiss equities with the SPI index as the starting point. The stock selection focuses on the strengths of Swiss companies. In addition to the global leaders, especially in the pharmaceutical, food and financial sectors, we pay particular attention to second-line stocks. Among these, we focus in particular on companies with above-average growth potential that benefit from megatrends as structural winners or hold a leading market position.

The fund is intended for risk-conscious equity investors who are convinced of the medium to long-term potential of Swiss companies. The fund is aimed exclusively at qualified investors.
