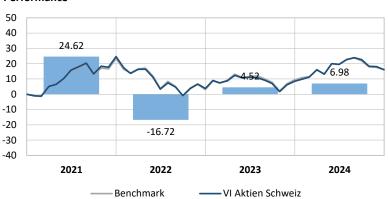
Investment focus and suitability
