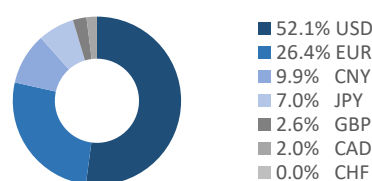

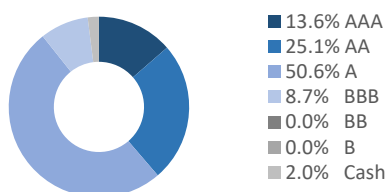

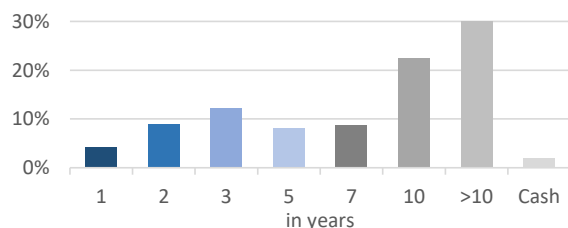
## Currency allocation

## Term to Maturity allocation

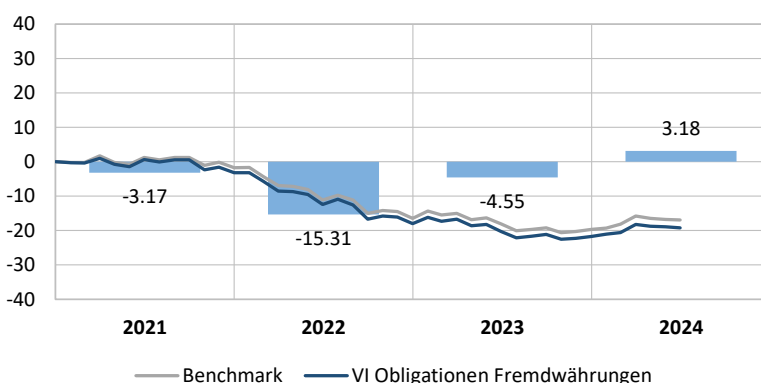


## Investment focus and suitability
