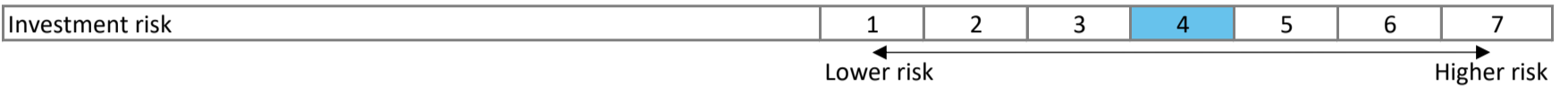

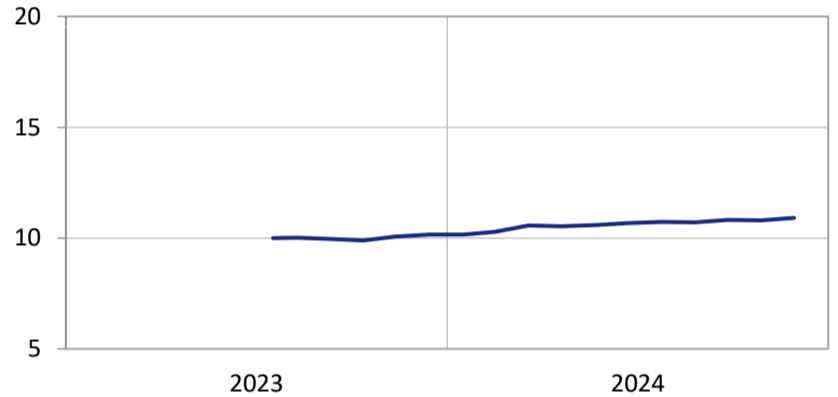

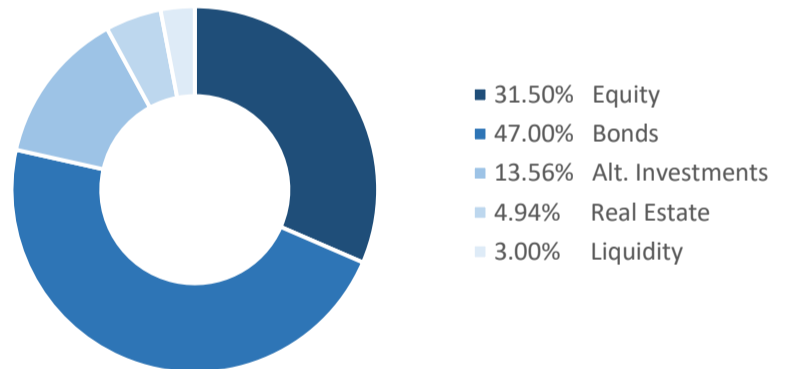

Current asset-allocation



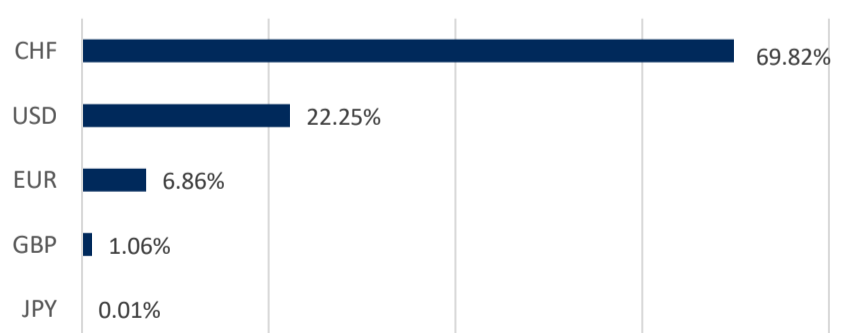
