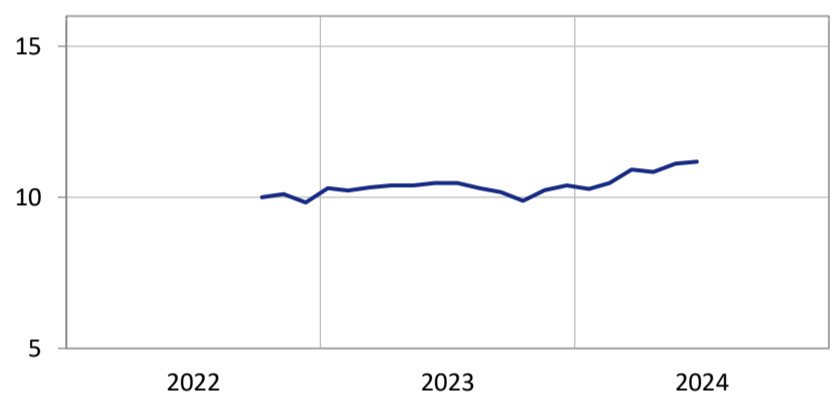

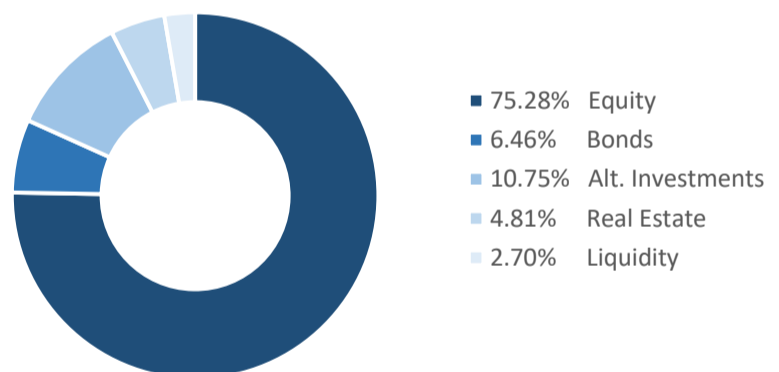

Current asset-allocation



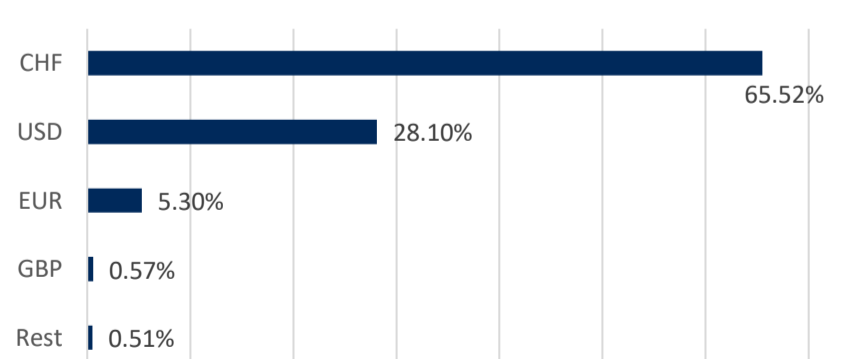
