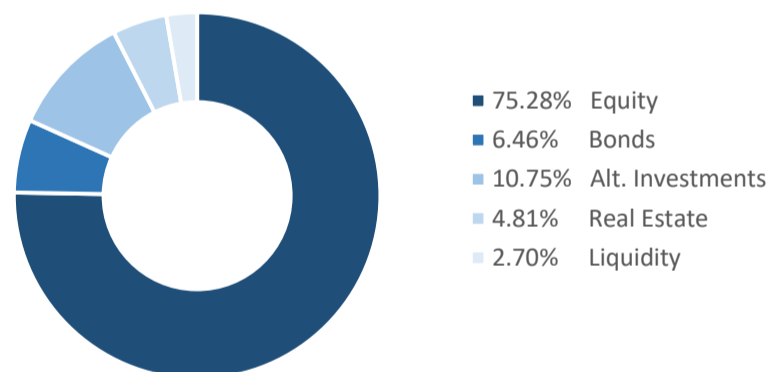

### Current asset-allocation



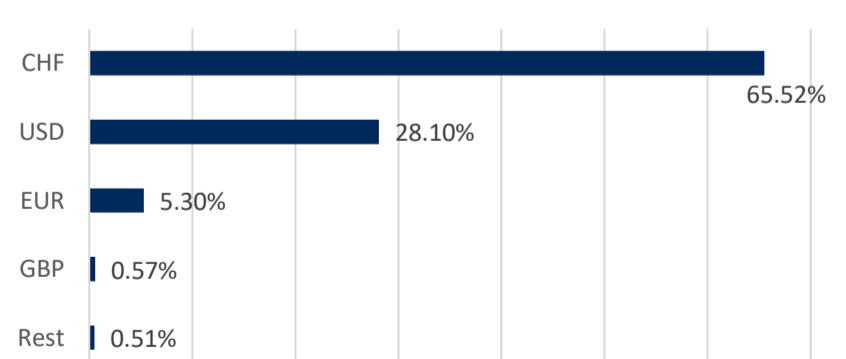
