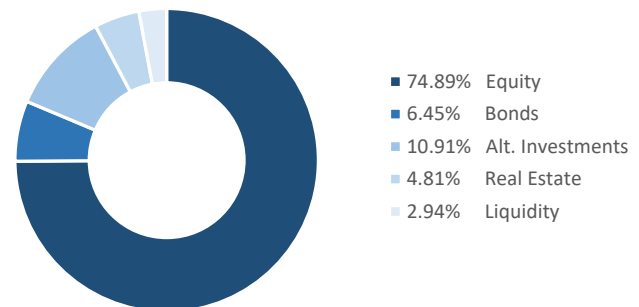

Net performance (in %)

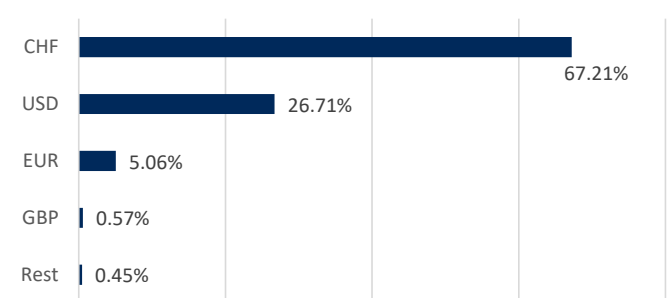
