

The geographic focus is primarily on the United States of America. However, the fund may also invest to a lesser extent in the EU, Australasia and other technology-oriented regions. Companies are selected primarily on the basis of the following criteria: Strategic focus, strong market position, first-class management, solid earnings situation and growth potential. Active stock selection is used to achieve the fund's investment objective.




