## **INVESTMENT OVERVIEW**

#### Objective

The fund is managed without reference to an index.


## **Portfolio Assets**

The fund invests primarily in government instruments and highly rated short maturity government bonds. These investments are denominated or hedged in Swiss francs so that the exchange rate risk is non-existent or limited.

## **Investment Process**

To actively manage the fund, the investment manager uses market, interest rate and credit risk analysis to select securities that it believes offer the best risk-adjusted returns. The manager constructs its portfolio in accordance with Pictet Asset Management's responsible investment principles. It mainly selects investments with a high ESG profile. The fund's investment policy is similar to that of an "Article 8" financial product according to the European Union's regulations on sustainable investment information.








## Risk Country (% of asset)




## Maturity profile (% of asset)

## Conversion fee

Fee paid for the transfer of shares of one unit/share class to another unit/share class.

## Inception date

The inception date is the date taken into account for the start of performance calculation. It corresponds to the launch date.

# NAV

An acronym of net asset value. **Ongoing Costs** 

The ongoing costs figure is based on expenses for the last 12 months. This figure may vary from year to year. It includes the management fees and other administrative or operating costs. It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit charge paid by the

Compartment when buying or selling

units/shares in another collective investment undertaking. For funds created less than 12 months ago, future costs are estimated.

## Order deadline

Deadline for remittance of orders to the transfer agent in Luxembourg as set out in the relevant annexes to the prospectus. You may be required to submit your orders to your financial advisor or fund distributor by an earlier cut-off time.

## Rating

The rating is a score awarded by rating agencies reflecting their opinion on the creditworthiness of an issuer.

#### SRI

and credit risk measures.

Standard deviation and annualised volatility

Annualised volatility is a risk indicator showing the extent of the price fluctuations of a security or fund unit compared to its average price over a given period. The higher the volatility, the greater the fluctuations.

Variable Net Asset Value (VNAV)
Variable Net Asset Value or VNAV, refers to funds which use mark-to-market and mark to model accounting models to value their assets.

Weighted average life (WAL)
WAL stands for 'Weighted Average Life'. It is used as an indication of credit risk.


