#### INVESTMENT OVERVIEW

## Objective

To increase the value of your investment, through income and investment growth. A sustainable strategy of low carbon emission exposure in view of achieving the objectives of the Paris Agreement is also applied.

#### Reference Index

FTSE WBGI All Maturities Hedged to USD, an index that does not take into account environmental, social and governance (ESG) criteria. Used for risk monitoring, performance objective and performance measurement.

#### Portfolio Assets

The Fund mainly invests in government bonds issued by countries that are reducing their greenhouse gas emissions and carbon intensity (net of land and forestry management) or in the opinion of the Investment Manager are in the process of implementing policies that may lead to a meaningful improvement. The Fund may invest worldwide, including in emerging markets and Mainland China, and can invest across



#### grade. Investment Process

In actively managing the Fund, the Investment Manager selects countries based on their carbon emissions reduction and following uses a combination of macroeconomic, market and issuer analysis to build a diversified portfolio of securities it believes offer the best risk-adjusted returns. The Fund's management approach uses strict risk controls. There may be engagement with countries to positively influence climate related matters. For further information, please refer to our exclusion framework in the Responsible Investment policy\* SFDR product category Article 9.The performance of the Fund is likely to be significantly different from that of the benchmark, because the Investment Manager has significant discretion to deviate from its securities and weightings.






#### Maturity profile (% of asset)

# FINANCIAL GLOSSARY

### Active duration risk

Is the difference between the fund duration and the benchmark duration. Alpha

Alpha shows the percentage performance of a fund above or below that explained by its exposure to the broader market.

# Average Coupon

The average coupon shows the price weighted aggregate coupon of instruments in a portfolio.

# Average Yield

The average yield shows the price weighted yield of instruments in a portfolio. Any hedging cost at a share class level is not included in this calculation.

### Beta

Beta shows the average extent a fund's return moves relative to the broader market. A fund with a beta above 1 moves on average more than the market and below 1 moves on average less than the market.

# Conversion fee

Fee paid for the transfer of shares of one

unit/share class to another unit/share class.

# Correlation

Correlation shows how a fund's return moves in relation to the benchmark. Highly correlated investments tend to move up and down together while this is not true for investments with low correlation.

# Inception date

The inception date is the date taken into account for the start of performance calculation. It corresponds to the launch date

# Information ratio

The information ratio is a way of measuring the value added by the portfolio manager relative to a benchmark. It is a measure of the riskadjusted return of a portfolio and is calculated by dividing the active return (portfolio return minus benchmark return) by the tracking error.

### NAV

An acronym of net asset value. Ongoing Costs

The ongoing costs figure is based on

expenses for the last 12 months. This figure may vary from year to year. It includes the management fees and other administrative or operating costs. It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit charge paid by the Compartment when buying or selling units/shares in another collective investment undertaking. For funds created less than 12 months ago, future costs are estimated.

# Order deadline

Deadline for remittance of orders to the transfer agent in Luxembourg as set out in the relevant annexes to the prospectus. You may be required to submit your orders to your financial advisor or fund distributor by an earlier cut-off time.

## SRI

The Summary Risk Indicator (SRI) is defined by the PRIIPs regulation and is designed to show the relative risk of a product, using a combination of market and credit risk measures.

Sharpe ratio



The Sharpe ratio shows the fund's riskadjusted performance. It is calculated by dividing the excess return (portfolio return minus risk free return) by the volatility.

Standard deviation and annualised volatility

Annualised volatility is a risk indicator showing the extent of the price fluctuations of a security or fund unit compared to its average price over a given period. The higher the volatility, the greater the fluctuations.


Tracking error

Tracking error shows the standard deviation of the active returns (portfolio return minus benchmark return). It measures how close a fund return is to its benchmark return.



This indicator measures the amount of carbon produced per unit of Gross Domestic Product (GDP), measured in Kton per m of gross domestic product (GDP). GHG emissions include both territorial and traded emissions from energy use, land use, land use changes and forestry.

Labelled bonds (%-weight)

Labelled bonds include green, social and sustainability bonds. Classification of labelled bonds is provided by the bond issuer and may not reflect our internal view.

#### SFDR Classification

Article 9: Investments that target economic activities that are environmentally and/or socially sustainable, provided that the companies in which the investments are

made follow good governance practices.
