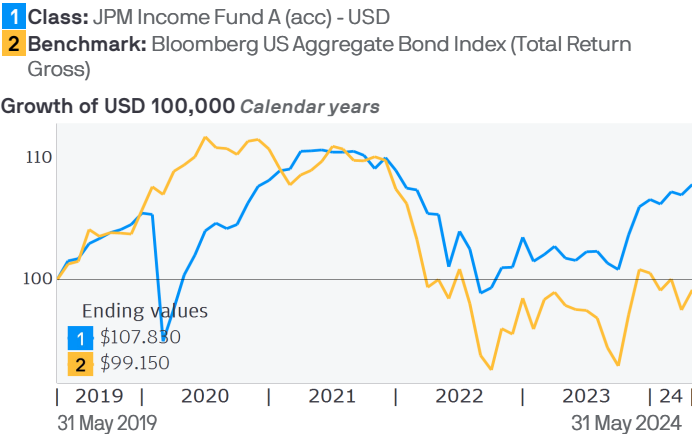

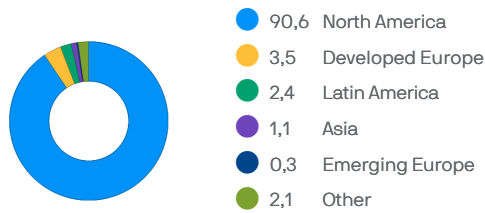

Definitions
