Fund description





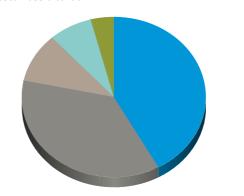
