

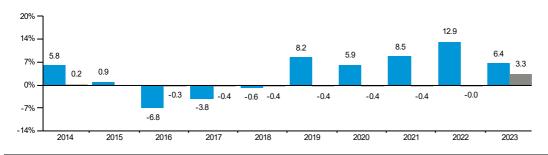

Glossary
