



Glossarv

Expected shortfall: is a risk measure to evaluate the market risk or credit risk of a portfolio

Ongoing charge: the ongoing charge is a measure of the annual expenses incurred by a fund and is expressed as a percentage. It allows an accurate comparison of the costs of funds from different companies to be made
