## Investment objective and overview

The investment objective of the Fund is to achieve capital preservation accompanied by stable returns via a dynamic asset allocation, using a flexible approach. The Fund seeks to achieve this objective by investing either directly or indirectly via collective investment schemes (primarily UČITS schemes) and financial derivatives (e.g. index options) to gain exposure on a worldwide basis to a number of asset classes.




