

Fund description

Investment objective and overview

The investment objective of the Fund is to achieve capital appreciation with the aim of generating a capital return in excess of global equity markets over the medium to long term. The Fund seeks to achieve this investment objective by gaining exposure to equity and equity hedge strategies through investment in equities and equity related securities and/or indirectly through financial derivative instruments and/or open-ended collective investment schemes (primarily UCITS schemes) deploying equity long only and equity hedge strategies and exchange traded Funds.

Opportunities

The Fund invests in a broadly diversified equity universe and seeks opportunities for returns wherever they exist. The objective is to identify the potential investments that, in the Investment manager's opinion, are attractive and could generate positive opportunities for investors. A highly qualified and experienced management team actively manages the Fund on the basis of a fundamental valuation approach.

Risk factors

Changes in exchange rates will have an impact on the value of shares in the Fund which are not denominated in the base currency. 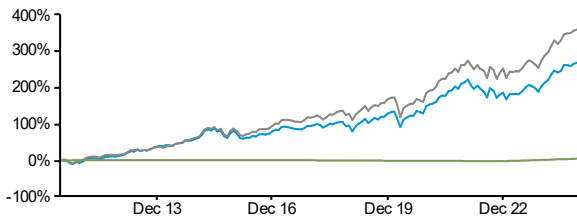

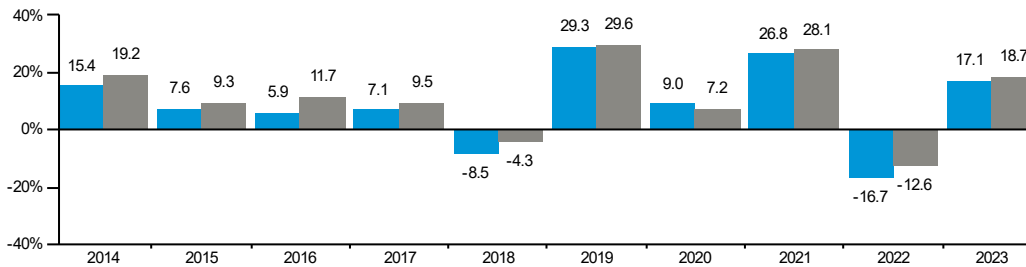

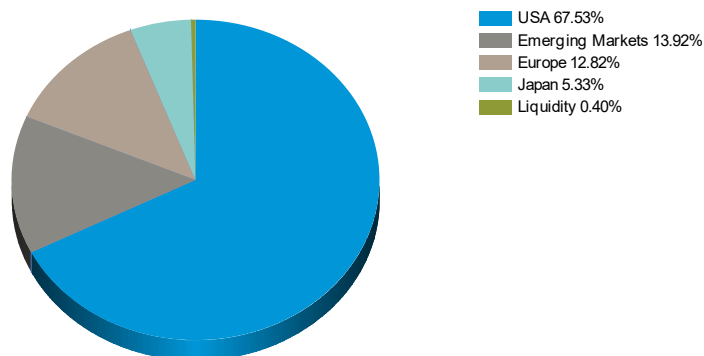

Glossary
