Fund description

Investment objective and overview

CAT Bonds are debt securities that transfer the risk of catastrophic events from insurance companies, reinsurance companies, corporations, governments, etc. to the capital markets.

The Fund gives investors easy access to cat bonds, which offer a low correlation to traditional asset classes,









Top 10 contributors to portfolio expected loss by peril



Glossary
