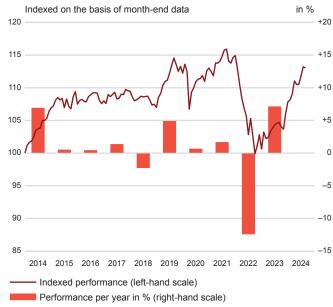
### **Fund description**

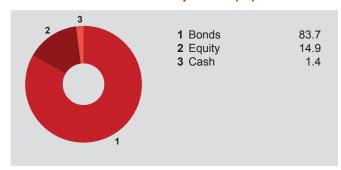
