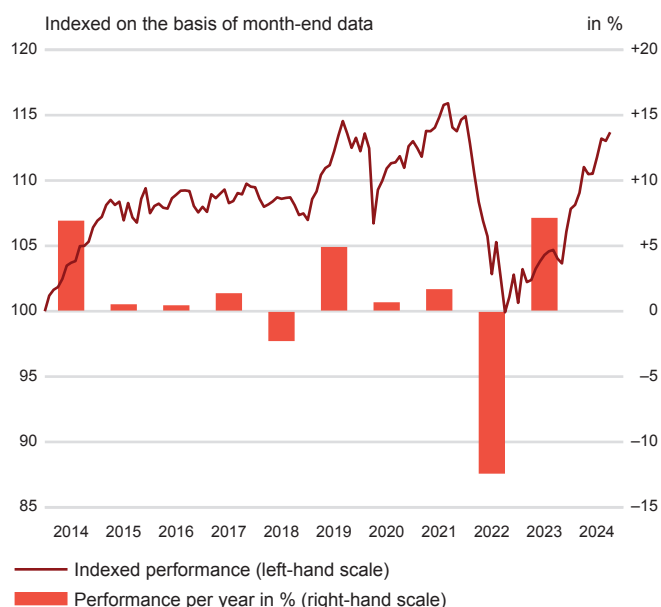

This fund is suitable for investors who would like to profit mainly from the return opportunities in the bond markets and partly also from share price gains.

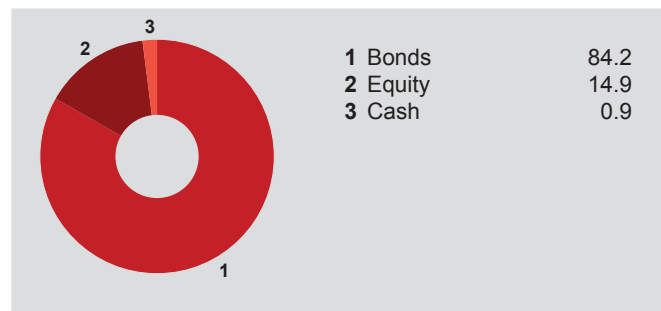

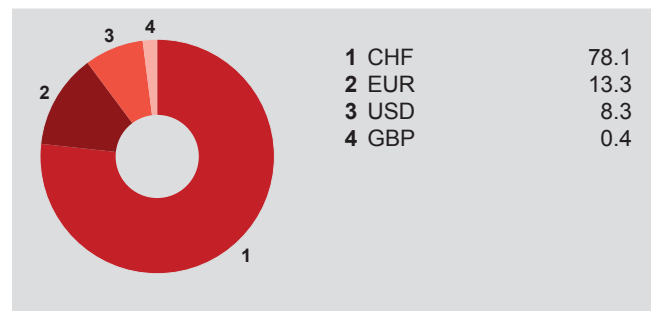
