Fund description


GENERALI Multi INDEX 20 is an investment fund under Swiss law in the «Other funds for traditional investments» category, and it is a balanced investment form. The investment goal is primarily to increase the fund's assets and produce stable results.

The fund invests a minimum of 51% of its assets in other collective investment schemes (target funds). The remaining 49% may be invested in equities and bonds, the equity portion must not exceed 30%.

The fund management company must also follow the investment rules in the Swiss Federal Law on Occupational Retirement, Survivors' and Disability Pension Plans (BVV2).

This fund is suitable for investors who would like to profit mainly from the return opportunities in the bond markets and partly also from share price gains.




