

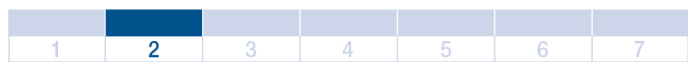

Current fund strategy

Raiffeisen-ESG-Euro-Corporates (ein Anlagefonds von Raiffeisen Capital Management Österreich) (R) is a bond fund. It invests primarily in EUR-denominated corporate bonds from higher rating classes (investment grade). The Fund promotes ecological/social characteristics and to this end it invests in bonds on the basis of ESG (environmental, social, governance) criteria. At least 51% of the Fund's investments are sustainable with social and environmental objectives; at this time, investment in line with the EU Taxonomy Regulation is not targeted. It is particularly suitable for investors who wish to benefit from the earnings potential of a well-diversified investment in EUR-denominated corporate bonds with good ratings while at the same time supporting sustainable business practices and who are aware of the related higher risks, ranging from elevated price volatility to possible loss of capital.

The fund is actively managed with reference to a benchmark. Such reference to a benchmark does not restrict the fund management's scope of action.

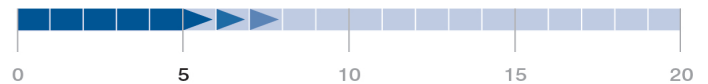

Recommended holding period in years



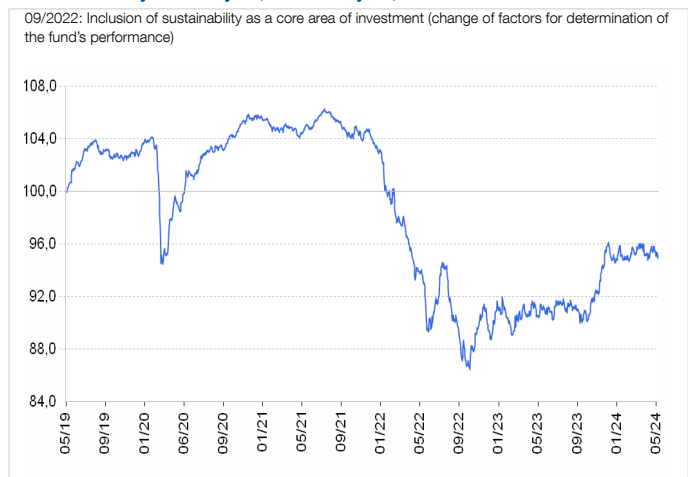
Comments from fund management

The European bond markets did not move in any clear direction in May. Inflationary pressure declined in Europe and in the United States. At the same time, the labour market situation in the USA was settling down, after being overheated. Demand for corporate bonds is still good, which led to increased new issuance in May.

Corporate bonds with very good ratings such as Novo Nordisk and Münchner Rück were bought on the primary market over the course of the month. We see attractive valuations in the bond market, so the portfolio remains fully invested.

We think that the ECB will make its first key rate cut in June, which should create good conditions for corporate bonds. (23.05.2024)

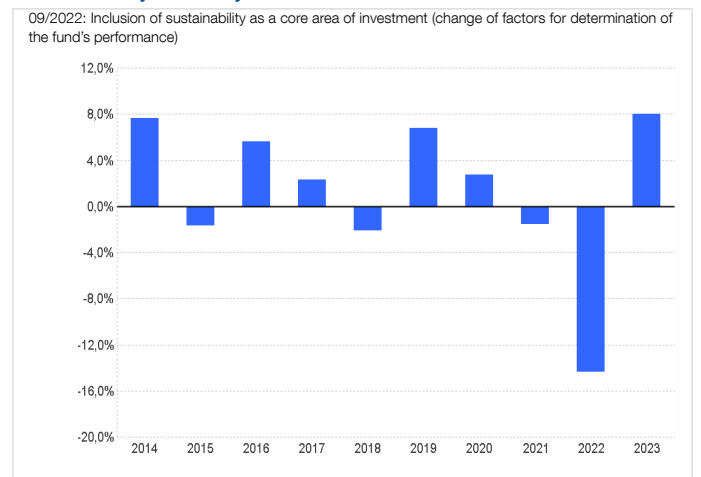
Performance 5 years: May 31, 2019 - May 31, 2024

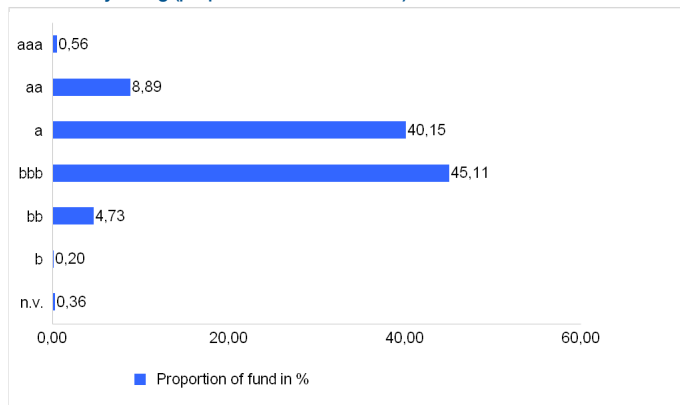
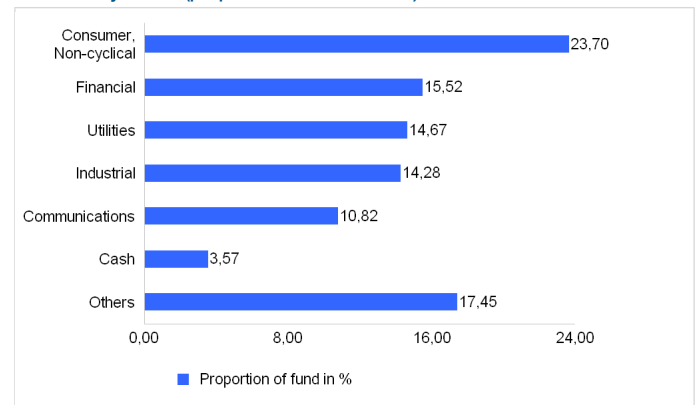
