Current fund strategy

Raiffeisen-Nachhaltigkeit-Aktien (ein Anlagefonds von Raiffeisen Capital Management Österreich) (R) is an equity fund. It invests in equities, with broad, global diversification. The Fund promotes ecological/social characteristics and to this end it invests on the basis of ESG (environmental, social, governance) criteria. At least 51% of the Fund's investments are sustainable with social and environmental objectives; at this time, investment in line with the EU Taxonomy Regulation is not targeted. There is no investment in certain sectors such as armaments or green/plant-based genetic engineering, as well as in companies that violate labour and human rights. The Fund is particularly suitable for investors who wish to benefit from the earnings potential of a globally diversified equity investment while supporting sustainable business practices and are aware of the risks, ranging from high price volatility to possible loss of capital.

The fund is actively managed without reference to a benchmark.



Recommended holding period in years




Comments from fund management

The international equity markets were friendly in October. Despite the pricing out of interest rate cuts in the USA, the markets rose thanks to the positive start to the reporting season and a weak euro. The fund also did well under these conditions. While the IT and financial sectors delivered the strongest positive performance contributions, companies in the consumer staples and consumer discretionary segments made the most significant negative contributions.

The fund's fundamentally broad diversification was maintained. The portfolio is still invested in issuers with the best sustainability and financial scores.

The developments in the coming months will primarily depend on the measures taken by the central banks going forward, economic growth in the USA and Europe, and the outcome of the US election. A close eye is also being kept on geopolitics. (23.10.2024)


