## Current fund strategy

Raiffeisen-Nachhaltigkeit-Mix (ein Anlagefonds von Raiffeisen Capital Management Österreich) (R) is a mixed fund. The Fund promotes ecological/social characteristics and to this end it invests in equities and bonds on the basis of ESG (environmental, social, governance) criteria. At least 51% of the Fund's investments are sustainable with social and environmental objectives; at this time, investment in line with the EU Taxonomy Regulation is not targeted. There is no investment in certain sectors such as armaments or green/plant-based genetic engineering, as well as in companies that violate labour and human rights. The Fund is particularly suitable for investors who wish to benefit from the earnings potential of a globally diversified capital investment while supporting sustainable business practices and are aware of the risks, ranging from high price volatility to possible loss of capital.

The fund is actively managed without reference to a benchmark.

#### Comments from fund management

The international equity markets were friendly in October. Despite the pricing out of interest rate cuts in the USA, the markets rose thanks to the positive start to the reporting season and a weak euro. The government bond markets in the USA and Europe lost some ground in October. After signs of a somewhat more positive economic trend in the USA, investors in Europe also began to reconsider their expectations for the aggressiveness of the ECB's interest rate path in the coming months. The fund's performance was positive in this environment.

The fund invests with broad diversification in bonds and equities of responsible companies and governments. The equities allocation is currently around 50% and holdings in corporate bonds changed little, at around 25 %.

The developments in the coming months will primarily depend on the measures taken by the central banks going forward, economic growth in the USA and Europe, and the outcome of the US election. A close eye is also being kept on geopolitics. (23.10.2024)

#### Performance 5 years: Oct 31, 2019 - Oct 31, 2024


09/2014: Inclusion of sustainability as a core area of investment (change of factors for determination of the fund's performance)

09/2014: Inclusion of sustainability as a core area of investment (change of factors for determination of the fund's performance)




